## General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
  This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

#### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.

  - the scripts of the candidates specified on the bar code label provided

# Specific information for this practical exam

### **Preparation of materials**

dialysis tubing

The dialysis tubing should fit inside a large test-tube when filled with liquid. Dialysis tubing with a flat width of between 20 mm to 25 mm will be suitable.

Cut 20 cm lengths of dialysis tubing. The dialysis tubing should be soaked for at least 10 minutes in water and then knotted, approximately 1 cm from one end, before being provided to candidates. Only one end of the dialysis tubing should be knotted so that a bag is formed with one open end and one knotted end. Soaking may be done overnight. Knotted dialysis tubing should be presented to candidates submerged in water in a suitable container.

1 mol dm<sup>−3</sup> sucrose solution

This can be prepared two days before the exam and should be stored in a cool place. It is not necessary to use AnalaR sucrose; table sugar will be suitable. The solution should be given to candidates at room temperature or at least 20 °C.
