## General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

### Safety

### Before the exam

- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- Where specified, the supervisor must perform the experiments and record the results as instructed.
  This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.

- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### **Preparation of materials**

1 mol per dm<sup>3</sup> sucrose solution

This can be prepared two days before the examination and stored in a cool place. It is not necessary to use AnalaR sucrose; table sugar will be suitable. The solution should be given to candidates at room temperature or at least 20 °C.

potato cylinders

White potatoes (*Solanum tuberosum*) are suitable. A cork borer can be used to make the cylinders. It is important that the cylinders are of the same diameter and ideally 3 mm in diameter. However, a diameter of 4 mm is acceptable. The outer potato skin should be removed and the cylinders must be at least 45 mm in length.
