### For Question 1

Each candidate will require

- (a) 50 cm<sup>3</sup> measuring cylinder
- (b) 10 cm<sup>3</sup> measuring cylinder
- (c) 250 cm<sup>3</sup> conical flask
- (d) 250 cm<sup>3</sup> of an aqueous solution of sodium thiosulfate, Na<sub>2</sub>S<sub>2</sub>O<sub>3</sub>.5H<sub>2</sub>O, containing 25g per dm<sup>3</sup> made up in distilled water, labelled **aqueous sodium thiosulfate**
- [H] (e) 100 cm<sup>3</sup> of hydrochloric acid of concentration 2.0 mol/dm<sup>3</sup> labelled hydrochloric acid for Question 1
  - (f) access to water and distilled water
  - (g) teat pipette
  - (h) a stop clock or timer which can measure to the nearest second; candidates may use their own watches if they are suitable

## For Question 2

### Each candidate will require

- [H] (a) a stoppered boiling tube containing about 0.5g of ammonium iodide, NH₄I, and 0.5g of barium carbonate, BaCO₃, labelled mixture of J and K
  - (b) filtration apparatus and filter paper
  - (c) rack of six test-tubes
  - (d) pH indicator papers and chart
  - (e) access to water and distilled water
- [H] (f) aqueous sulfuric acid of concentration 1.0 mol/dm<sup>3</sup>, labelled sulfuric acid
- [H] (g) aqueous hydrochloric acid of concentration 2.0 mol/dm<sup>3</sup>, labelled hydrochloric acid
- [H] (h) limewater and apparatus commonly used to test for carbon dioxide
- [N][H] (i) aqueous silver nitrate of concentration suitable to give a positive halide test, labelled silver nitrate solution
- [C] (j) aqueous nitric acid of concentration 0.5 mol/dm<sup>3</sup>, labelled nitric acid
- [C] (k) aqueous sodium hydroxide of concentration 1.0 mol/dm<sup>3</sup>, labelled sodium hydroxide
- [H] (I) aqueous hydrogen peroxide of concentration 20 volumes (6%), labelled hydrogen peroxide
  - (m) access to solid soluble starch
  - (n) spatulas
  - (o) splints
  - (p) test-tube holder
  - (q Bunsen burner and matches
  - (r) teat pipettes
  - (s) 10 cm<sup>3</sup> measuring cylinder

Labels do not need to include concentrations.
