### For Question 1

Each candidate will require

- (a) a 25 cm<sup>3</sup> or 50 cm<sup>3</sup> measuring cylinder
- (b) a 50 cm<sup>3</sup> burette and stand
- (c) a 250 cm<sup>3</sup> conical flask
- (d) 75 cm<sup>3</sup> of aqueous potassium manganate(VII), KMnO<sub>4</sub>, of concentration 4.0 g/dm<sup>3</sup> labelled solution M
- (e)  $75 \text{ cm}^3$  of aqueous potassium manganate(VII), KMnO<sub>4</sub>, of concentration  $8.0 \text{ g/dm}^3$  labelled solution N
- (f)  $100 \text{ cm}^3$  of aqueous iron(II) ammonium sulfate-6-water,  $(NH_4)_2\text{Fe}(SO_4)_2.6H_2O$ , of concentration  $40 \text{ g/dm}^3$  made by dissolving 40 g of the salt in  $100 \text{ cm}^3$  of sulfuric acid of concentration  $1 \text{ mol/dm}^3$ , and diluting to  $1000 \text{ cm}^3$  with distilled water, labelled **solution L**
- (g) a teat pipette
- (h) access to water and distilled water
- (i) a white tile
- (j) funnel (for filling burette)

### For Question 2

Each candidate will require

- [H] (a) a stoppered test-tube containing about 1 g of tartaric acid (2,3-dihydroxybutanedioic acid), HOOCCH(OH)CH(OH)COOH, labelled solid P
- [N] [H] (b) a stoppered test-tube containing about 0.5g of anhydrous copper sulfate, CuSO<sub>4</sub>, labelled solid Q
  - (c) distilled water
  - (d) splints
  - (e) rack of ten test-tubes including a hard-glass test-tube
  - (f) pH indicator papers and chart
  - (g) access to solid sodium hydrogen carbonate
- [F] (h) access to magnesium powder
- [N] [H] (i) access to copper(II) oxide powder
  - (j) test-tube holder
- [C] (k) aqueous sodium hydroxide of concentration 1 mol/dm<sup>3</sup>
  - (I) aqueous ammonia of concentration 1 mol/dm<sup>3</sup>
  - (m) a 10 cm<sup>3</sup> measuring cylinder
  - (n) a Bunsen burner and matches
  - (o) teat pipettes
  - (p) a spatula
  - (q) a stirring thermometer, 0-110 °C
  - (r) a boiling tube
  - (s) access to clock or stop watch

Labels do not need to include concentrations.
