For Question 1

Each candidate will require

- (a) one 10 cm³ measuring cylinder
- (b) one stirring thermometer, -10 to +110 °C at 1 °C graduations
- (c) one boiling tube in a rack
- (d) two samples of 1 g of fine iron filings, in stoppered test-tubes, each labelled 1 g of iron
- [F][N] (e) one sample of 1 g of zinc powder, in a stoppered test-tube, labelled 1 g of zinc
- [F] (f) two samples of 1g of magnesium powder, in stoppered test-tubes, each labelled 1g of magnesium
 - (g) 50 cm³ of aqueous copper(II) sulfate, CuSO₄.5H₂O, of concentration 0.2 mol/dm³, labelled copper(II) sulfate solution
 - (h) 50 cm³ of aqueous hydrochloric acid of concentration 1.0 mol/dm³ labelled dilute hydrochloric acid
 - (i) access to water and distilled water
 - (j) Bunsen burner and matches
 - (k) splints

For Question 2

Each candidate will require

- [O][MH] (a) a stoppered boiling tube containing a mixture of about 0.5 g of zinc nitrate, Zn(NO₃)₂.6H₂O, and 1 g of powdered lithium carbonate, Li₂CO₃, labelled mixture of solids G and H
 - (b) filtration apparatus, filter funnel and filter paper
 - (c) one boiling tube and stopper
 - (d) distilled water
 - (e) apparatus for a flame test One method is to dip a wooden splint into dilute hydrochloric acid and then into the solid, followed by insertion into a blue flame.
 - (f) rack of six test-tubes
- [MH] (g) limewater and apparatus commonly used to test for carbon dioxide
 - (h) litmus paper
- [MH][N] (i) agueous silver nitrate of suitable concentration to give a positive halide test
- [C] (j) aqueous nitric acid of concentration 1 mol/dm³
- [MH][N] (k) aqueous ammonia of concentration 1 mol/dm³
- [C] (I) aqueous sodium hydroxide of concentration 1 mol/dm³
 - (m) aluminium foil
 - (n) aqueous hydrochloric acid of concentration 1 mol/dm³
 - (o) 10 cm³ measuring cylinder
 - (p) Bunsen burner and matches
 - (q) teat pipettes
 - (r) spatula

Note: Labels do not need to include concentrations.
