Question 1

Each candidate will require the following chemicals and apparatus. Labels must **not** include concentrations.

- [C] (a) 150 cm³ of aqueous sodium hydroxide of concentration 1.0 mol/dm³ labelled aqueous sodium hydroxide for Question 1
 - (b) 100 cm³ of dilute hydrochloric acid of concentration 2.0 mol/dm³ labelled acid R
- [C] (c) 100 cm³ of dilute sulfuric acid of concentration 2.0 mol/dm³ labelled acid S
 - (d) access to water and distilled water
 - (e) 50 cm³ measuring cylinder
 - (f) 250 cm³ beaker
 - (g) 50 cm³ burette with stand and clamp
 - (h) funnel for filling burette
 - (i) stirring thermometer, -10 °C to +110 °C at 1 °C graduations
 - (j) polystyrene cup
 - (k) teat pipettes

Question 2

Each candidate will require the following chemicals and apparatus. Labels do **not** need to include concentrations.

- [C] (a) 8 cm³ of aqueous sodium hydroxide of concentration 1 mol/dm³ in a stoppered test-tube labelled solution T
- [F][MH] (b) 3 cm³ of propanone in a stoppered test-tube labelled liquid U
 - [MH] (c) access to solid ammonium chloride
 - (d) aqueous chromium(III) chloride of concentration 0.1 mol/dm³
 - [N] (e) $10\,\mathrm{cm^3}$ of aqueous iodine in potassium iodide (0.25 g of iodine, I_2 , and 0.8 g of potassium iodide, KI, dissolved in distilled water to give $10\,\mathrm{cm^3}$ of solution)
 - [C] (f) aqueous sodium hydroxide of concentration 1 mol/dm³
- [MH][N] (g) aqueous zinc sulfate of concentration 0.1 mol/dm³
 - (h) distilled water
 - (i) pH indicator papers and chart
 - (j) red and blue litmus paper
 - (k) 10 cm³ measuring cylinder
 - (I) watch glass
 - (m) splints
 - (n) apparatus for a flame test
 - (o) Bunsen burner and matches
 - (p) rack of test-tubes
 - (q) $2 \times \text{boiling tubes}$
 - (r) stopper to fit test-tubes
 - (s) test-tube holder
 - (t) teat pipettes
 - (u) spatula
