Before the exam

- The packets containing the question papers must **not** be opened before the exam.

During the exam

- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.

- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.
