**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

	<p>Level 6 Explains purpose in context of 29 October 1962 (on 28 October Khrushchev accepts Kennedy's offer or Khrushchev agreed to withdraw the missiles) <b>Note:</b> Needs a valid message but not necessarily the big message</p>	8
	<p>Level 5 Explains the purpose of the cartoon (must have an impact on audience in the answer, e.g. to persuade the American people it was a massive victory for the US) <b>Note:</b> Needs a valid message but not necessarily the big message</p>	7
	<p>Level 4 Explains the big message – the Russians have been overwhelmed (or humiliated) by US power. Need both parts</p>	6
	<p>Level 3 Explains specific context only – fails to explain message or purpose of cartoon <b>OR</b> Explains a valid sub-message</p>	4–5
	<p>Level 2 Misreading of the cartoon <b>OR</b> Interprets cartoon or describes the context – but not used as a reason for publication <b>OR</b> General context only – no message or purpose</p>	2–3

	<p>Level 5 Explains point of view of cartoonist – Khrushchev is <b>lying</b> because he has let Castro down (explicit reference to the words at top of cartoon not necessary)</p>	8
	<p>Level 4 Explains that Castro/Cuba suffered <b>more</b> from the outcome of the Crisis than Khrushchev/USSR – the comparison here is key (explicit reference to the words at top of cartoon not necessary)</p>	6–7
	<p>Level 3 Sub-message(s) explained, e.g. messages that accept that Khrushchev was hurting more or messages that ignore the words at the top and explain how badly Khrushchev has treated Cuba/Castro</p>	3–5
	<p>Level 2 Plausible misinterpretations of the message OR Interpretations of details e.g. the teeth represent the missiles</p>	2
	<p>Level 1 Surface description of source</p>	1

	<p>Level 3 Cross-reference to sources or contextual knowledge to either confirm claims of G or to suggest other valid motives</p>	4–5
	<p>Level 2 Answers that explain how the content of G does/does not prove this</p>	2–3
	<p>Level 1 Writes about the sources but does not address the question of proof <b>OR</b> Answers not supported from the source e.g. assertions that he cannot be believed <b>OR</b> Answers based just on provenance</p>	1
