### Section A: The American Civil War, 1861-1865

Study the Background Information below and then answer **all** the questions. Use your knowledge to topic to help you interpret and evaluate the sources, as appropriate.

### **Background Information**

During the conflict, men volunteered to serve for either the Union or the Confederate army. By January 1863 the Union army had mobilized about one million men and the Confederate army about half that number. With desertions and the loss of territory, Confederate strength declined and by the end of the war the North had a superiority of 4:1. Soldiers of both sides endured great suffering and many performed with bravery and commitment on the field of battle. Similarly, some generals were brilliant as leaders and strategists but others were less impressive.
