## General comments

This was the first June series in which the Listening test was multiple-choice. Overall, performance was satisfactory. Most candidates attempted all questions.

The Spanish extracts heard by candidates gradually increased in terms of length and density and featured monologues, conversations and interviews. The emphasis of the questions moved from targeting the candidates' ability to pick out information contained in short factual pieces, to testing their ability to understand specific information, as well as opinions and explanations, in longer extracts.

## Comments on specific questions

## Questions 1-8

Performance in this exercise was generally very good, with most candidates answering the majority of questions correctly. Where mistakes did occur, this was most usually in Question 3 where there was confusion between falda (the correct answer - option A) and vestido (option B). In Question 4 candidates heard the phrase el chico moreno que lleva bigote, which related to option B; a number of candidates chose option A (un chico rubio que lleva bigote). In Question 6 approximately half of the candidature recognised the word llave (option D).

## Questions 9-14

Question 9: Almost all candidates identified hace sol in the recording and therefore chose option $\mathbf{C}$.
Question 10: The majority of candidates knew aeropuerto.
Question 11: Most candidates identified plantas.
Question 12: Nearly all candidates identified ruta en bicicleta.
Question 13: Many candidates understood los niños menores de diez años no pagan and therefore chose B, but some candidates chose option D, a picture of two young people.

Question 14: Some candidates understood the phrase las casas del parque and therefore selected option D, but a significant number chose either the caravan (option B) or the tents (option $\mathbf{C}$ ).

## Questions 15-19

This was a matching exercise in which candidates heard a conversation between two friends, Juan and Ana, about Juan's family. Many candidates performed well in this exercise.

Question 15: This was the question that was answered least well in this exercise. Many candidates did not grasp the phrase sonríe todo el tiempo y nunca se enfada, which linked with option $\mathbf{C}$ (está siempre de buen humor). Quite a few candidates chose option B (quiere comprar un coche nuevo).

Question 16: About two thirds of candidates understood lleva estudiando ruso doce meses and therefore chose option $\mathbf{A}$. Of the remaining candidates, a number chose option $\mathbf{E}$ (trabaja en un colegio).

Question 17: This was the question that was answered best in this exercise, with many candidates understanding the phrase enseñando ciencias en una escuela and linking it with option E (trabaja en un colegio).

Question 18: This question was not answered particularly well, with many candidates not understanding the phrase se fue a vivir a otro país. There was no clear pattern of mistakes.

Question 19: This question was generally tackled well, with many candidates correctly choosing option $\mathbf{F}$ (ha querido vivir junto al mar y va a mudarse).

## Preguntas 20-28

In this exercise, candidates heard an interview in two parts with Paula, who spoke about the use of mobile phones in her school. The exercise represented a step up in the incline of difficulty of the test.

Question 20: Some candidates identified the right answer (option C); many chose what they thought was a 'common sense' answer (option A) rather than listening to what was actually said in the recording.

Question 21: Less than half of the candidature answered this question correctly. Many chose option C, even though there was no mention in the recording of how frequently the headmaster used his phone.

Question 22: Almost all candidates understood yo sobre todo lo uso para encontrar información and therefore chose option B.

Question 23: This question was also well understood. Most candidates noticed the key phrase ha sugerido aplicaciones para aprender vocabulario and therefore selected option B.

Question 24: This question was not answered particularly well. Some candidates did find the right answer, having understood the phrase se ponen a ver sus correos electrónicos, but many were tempted by option B (cuentan mentiras al profesor).

Question 25: This question was also answered quite poorly. Many candidates option B because they heard something about finding a phone.

Question 26: This was the question that was answered least well in this exercise. Some candidates chose the correct answer (option C) because they identified the phrase se preocupan porque piensan que perdemos demasiado tiempo. Many opted for B because they misunderstood what was said about tiempo.

Question 27: Many candidates understood the phrase necesitamos un póster y un chico de mi clase que es muy bueno en arte lo hará and therefore chose the correct answer (option B).

Question 28: About half of the candidature found the correct answer (option A), having understood the phrase el mes que viene. Option B was chosen by nearly half the candidature, perhaps because they heard the phrase llevamos solo una semana pensando qué poner en el póster.

## Questions 29-34

Candidates heard an interview with Iván, a children's author who spoke about his recent book The Time Machine.

Question 29: Nearly all candidates understood the phrase quería dedicarme a escribir cómics and therefore chose option D.

Question 30: This was a straightforward question. Most candidates understood está recomendada para niños de más de ocho años and therefore selected option B.

Question 31: Some candidates were able to identify the key phrase in the recording and therefore chose option B, but a significant number chose option A, perhaps because they misheard the phrase al volver de las vacaciones.

Question 32: This question was not answered particularly well. Many chose option D because they heard la empresa con la que trabajo me ha llamado para que escriba la segunda parte de La máquina del tiempo.

Question 33: This question was the one that was answered least well in this exercise. Option A was the correct answer, but option B was the most commonly chosen answer, perhaps because of the statement mucha gente diría que lo esencial es leer.

Question 34: There was a range of answers here. Options B and C were the most commonly chosen incorrect answers.

## Questions 35-37

Candidates heard a dialogue between Mateo and Lucía, who spoke about an important wedding that had taken place in their city. For each question in this exercise, candidates had to identify two correct statements from a choice of five.

Question 35: A good number of candidates understood los tres días de la boda and therefore chose option B. Option $\mathbf{C}$ was one of the answers that candidates struggled to find in this exercise. Although the phrase eso dicen el periódico y la radio was relatively straightforward, very few candidates selected option C (la noticia ha salido en los medios de comunicación). Many candidates chose option E because they heard el vestido de la novia era espectacular, but were unable to understand the phrase that came after it in the recording (sin embargo, lo más maravilloso fueron los fuegos artificiales), which would have enabled them to eliminate option E as a potential correct answer.

Question 36: Some candidates were able to understand ha sido positivo para la economía de la ciudad (and therefore chose option $\mathbf{C}$ ) and esa es otra razón por la que a casi todo el mundo le fascinó este evento (and therefore selected option $\mathbf{D}$ ). Many candidates chose option B because they heard that the president envió una carta a los novios para disculparse; option B wasn't correct, though, because the president did not call them. A significant number chose option E, perhaps because they overlooked the first word in the phrase nunca antes habíamos tenido una boda como esta aquí.

Question 37: This question was the one that was answered best in this exercise. A good number of candidates understood tengo muy claro que voy a casarme algún día (and therefore chose option A) and me siento terriblemente incómodo si soy el centro de atención delante de mucha genteans (and therefore selected option D). Some candidates heard the word centro and selected option C. Option E was also a common incorrect answer, perhaps because the candidates had misheard ni siquiera pienso en encontrar pareja.

## Comments on specific questions

## Questions 1-8

Performance in this exercise was generally very good, with most candidates answering the majority of questions correctly. Where mistakes did occur, this was most usually in Question 2, with some candidates choosing option A (Iluvia) or option B (sol) rather than option D (viento). where there was confusion between falda (the correct answer - option A) and vestido (option B). In Question 5 a few candidates were tempted by one of the three incorrect options rather than the correct option, but there was no clear pattern of mistakes.

## Questions 9-14

Question 9: The majority of candidates knew las ocho menos diez (option B). A few chose option $\mathbf{D}$ instead.
Question 10: Almost all candidates identified the word biblioteca in the recording.
Question 11: Most candidates knew bolígrafo y papel and therefore chose option $\mathbf{C}$.
Question 12: This question was the one that was answered least well in this exercise. Many candidates identified ir andando and therefore chose option A. Some did not know the expression and tended to choose either option B (autobús) or option D (tren).

Question 13: Most candidates understood vestidos tradicionales.
Question 14: The majority of candidates identified pista de patinaje and therefore chose option $\mathbf{D}$. The most commonly chosen wrong answer was option C (discoteca).

## Questions 15-19

This was a matching exercise in which candidates heard a conversation between two friends, Sandra and Felipe, about sports. Many candidates performed well in this exercise.

Question 15: Most candidates understood the phrase hace dos semanas, decidí apuntarme a un curso and therefore selected option $\mathbf{A}$, but some candidates chose either option D or option F.

Question 16: About three quarters of candidates answered this question correctly, having understood the phrase los partidos son muy largos y tengo que estudiar mucho. The most commonly chosen wrong answer was option B.

Question 17: A number of candidates struggled with me ayuda a vivir una vida saludable. The most commonly chosen wrong answer was option $\mathbf{E}$.

Question 18: Most candidates understood the phrase tenemos clases en el instituto and therefore selected option F. Some chose option A instead.

Question 19: Many candidates identified the correct answer (option B). The most common wrong answer was option D.

## Questions 20-28

In this exercise, candidates heard an interview in two parts with Carolina, who spoke about what she had done to have a swimming pool installed in her town. The exercise represented a step up in the incline of difficulty of the test.

Question 20: Many candidates understood hemos perdido la discoteca que teníamos and therefore chose option C. Even though Carolina said hay un montón de cosas para hacer, a significant number of candidates chose option B (hay poco para la gente joven).

Question 21: The majority of candidates understood the phrase temperaturas difíciles de aguantar and therefore chose the correct answer (option A). Option B was the most common incorrect answer.

Question 22: This question was not answered particularly well. Some candidates worked out the correct answer (option C) from la gente espera desde las ocho de la mañana para entrar, but many chose option A because of they had heard the word ocho.

Question 23: Most candidates answered this question correctly, having understood the phrase en todas las aulas.

Question 24: Many candidates understood hicimos una grabación para el alcalde usando mi móvil y se la enviamos and therefore selected option B. The most common wrong answer was option A.

Question 25: The stronger candidates chose option B because they understood dijimos al director que salíamos del colegio un grupo de trescientos alumnos. Él dijo que sí. A significant number of candidates selected option A because they misunderstood sentía no poder acompañarnos.

Question 26: Many candidates identified option A as the correct answer because they understood una piscina sería demasiado cara para construir este año. Option B was the most common wrong answer.

Question 27: The stronger candidates understood una al aire libre donde juntarnos con los amigos and therefore chose option A. Some candidates selected option B, perhaps because they didn't understand or missed the beginning of the phrase no es una gran piscina cubierta donde los equipos puedan entrenarse.

Question 28: This was the question that was answered best in this exercise. Almost all candidates chose option B, having identified the phrase creo que lo conseguiremos para el año que viene in the recording.

## Questions 29-34

Candidates heard an interview with Javier, a professional gamer.
Question 29: Many candidates chose the correct answer (option B) because they understood the phrase hay nuevos jugadores jóvenes que compiten para sacarte.

Question 30: Nearly all candidates answered this question correctly.
Question 31: The stronger candidates opted for the correct answer (option B) because they understood estudiamos nuestros partidos anteriores en la gran pantalla. Option A was the most common wrong answer, even though Javier said pasamos dos horas en el gimnasio and also la salud y la forma física son esenciales, Candidates may not have been familiar with the verb evitar used in option A.

Question 32: This question was not answered particularly well. The stronger candidates chose option $\mathbf{C}$, having understood the phrase el deseo de mejorar siempre, but a significant number of candidates chose either option A or option B because they misinterpreted controlar las emociones and algunos siguen jugando el sábado y el domingo.

Question 33: The stronger candidates understood se aprende mucho con los videojuegos and therefore chose option $\mathbf{A}$, but a number of candidates selected option $\mathbf{B}$ because they heard the word película.

Question 34: Many candidates encountered difficulty here. The stronger candidates understood yo ahorro parte del dinero que me pagan and therefore chose option B, but a significant number of candidates did not find the correct answer. There was no clear pattern of mistakes.

## Questions 35-37

Candidates heard an interview with Roberto, a florist in Santa Catalina. For each question in this exercise, candidates had to identify two correct statements from a choice of five.

Question 35: The stronger candidates understood mis padres siempre compraban flores; era normal tenerlas en casa and therefore chose option A. Fewer candidates identified the second correct statement (option B); candidates needed to listen carefully in order to identify a los trece años, asistí a una fiesta...había flores que nunca había visto.

Question 36: A reasonable number of candidates understood es importante saber cómo cuidar y cortar flores para que tengan una vida más larga and therefore selected option B. In general, the majority of candidates didn't identify the second correct answer (option D). The most common incorrect answers were option C (probably because candidates misheard tenía que ganar dinero trabajando de noche para pagar los estudios) and option E (because they did not understand the phrase yo vuelo una vez al mes a la capital).

Question 37: A significant number of candidates did not find the first correct answer (option A); only the strongest candidates understood the phrase hay que aguantar mucho. In general, candidates coped much better with the second answer, with nearly three quarters of candidates choosing option $\mathbf{E}$. A few candidates misunderstood Javier's last utterance and selected option D instead.

## Comments on specific questions

## Questions 1-8

Where mistakes did occur, this was most usually in Question 2, with some candidates choosing option B (morena con gafas) rather than option D (rubia con gafas); the word gafas was understood but the word rubia was not. In Question 3 some candidates did not know sombrero (option C); the most common wrong answer was option B. In Question 4 some candidates had difficulty understanding helado (option A); there was no clear pattern of mistakes.

## Questions 9-14

Question 9: Almost all candidates understood siete y media and therefore chose option $\mathbf{D}$.
Question 10: Most candidates identified concierto escolar and therefore selected option A.
Question 11: The majority of candidates recognised pasteles (option B).
Question 12: Most candidates knew polideportivo and therefore chose option $\mathbf{C}$.
Question 13: Nearly all candidates identified fotógrafa and chose $\mathbf{C}$.
Question 14: This question was not answered particularly well. The stronger candidates identified the correct answer (option D - nublado). A significant number of candidates chose option $\mathbf{C}$ (viento).

## Questions 15-19

This was a matching exercise in which candidates heard a conversation between two friends, Paula and Jorge, about their friends. Many candidates performed well in this exercise.

Question 15: Many candidates understood the phrase es una persona tan alegre and therefore chose option $\mathbf{E}$. The most common wrong answer was option $\mathbf{A}$.

Question 16: Most candidates answered this question correctly.
Question 17: The majority of candidates identified the right answer to this question.
Question 18: This was the question that was answered best in this exercise. Nearly all candidates chose option B. In cases where the mark wasn't awarded, there was no clear pattern of mistakes.

Question 19: This was the question that was answererd least well in this exercise. The stronger candidates understood the phrase nadie del grupo hace lo mismo que él and therefore chose option A. A number of candidates selected option D instead.

## Questions 20-28

In this exercise, candidates heard a conversation in two parts between Carolina and her friend Manuel, who had moved to Mexico. The exercise represented a step up in the incline of difficulty of the test.

Question 20: There was a mixed response to this question. A reasonable number found the correct answer (option B), but a significant number chose option A instead.

Question 21: This question was generally not handled well, with less than half the candidature gaining the mark here. The correct answer was option C, but a significant number chose option A, and nearly half the candidates chose option B.

Question 22: This question was answered very well, with most candidates understanding the phrase hay muchos coches and therefore choosing option A.

Question 23: The stronger candidates understood the phrase hay mucho que hacer and therefore chose option C, but a significant number selected option A because they heard cerca del centro histórico at the start of Manuel's utterance and didn't continue listening to hear the key piece of information that followed.

Question 24: A number of candidates encountered difficulty with, with only about half the candidates identifying the correct answer (option B). The most common wrong answer was option $\mathbf{C}$.

Question 25: This was another question that wasn't answered particularly well. The stronger candidates were able to identify junto al mar and therefore chose option $\mathbf{C}$. Many candidates misunderstood the phrase no siempre estoy en la oficina and chose option B instead.

Question 26: The stronger candidates chose the correct answer (option B) because they understood the phrase me voy directo a la cama. A significant number selected option A because they heard the word museos.

Question 27: There was generally a very good response to this question. Most candidates picked out the phrase dos amigos argentinos vendrán a visitarme and therefore chose $\mathbf{A}$.

Question 28: The stronger candidates chose the correct answer (option A) because they understood the phrase era demasiado estresante. The most common wrong answer was option B.

## Questions 29-34

Candidates heard an interview with Elvira, who spoke about life in her village.
Question 29: This question was generally answered quite well. Many candidates chose option A because they understood the phrase mis padres me trajeron cuando era niña. Quite a few candidates were tempted by option A or option B instead.

Question 30: A good number of candidates chose the correct answer (option C) because they understood the phrase no había futuro para los jóvenes. However, a few candidates selected option A instead because they heard the phrase terminar la escuela.

Question 31: This was the question that was answered best in this exercise, with most candidates selecting the correct answer (option D).

Question 32: Many candidates encountered difficulty here. The stronger candidates understood se descubrieron unas piedras muy antiguas and therefore chose option A. The statement nos visitan algunos famosos artistas, actores led a significant number of candidates to choose option $\mathbf{B}$ instead.

Question 33: Most candidates answered this question correctly.
Question 34: In general, this question was not tackled well. The stronger candidates understood the phrase aprendemos los unos de los otros and therefore chose option B. A significant number of candidates chose option $\mathbf{D}$, and quite a number chose option $\mathbf{A}$.

## Questions 35-37

Candidates heard an interview with Daniel Alonso, a young dancer. For each question in this exercise, candidates had to identify two correct statements from a choice of five.

Question 35: Many candidates found the first correct answer (option A), and nearly all candidates found the second correct answer (option E).

Question 36: There was a mixed response to this question. Quite a number of candidates struggled to find the first correct answer (option C), with many choosing option A instead. They generally had more success finding the second correct answer (option D), although some did choose option E instead.

Question 37: This was the question that was answered least well in this exercise. The stronger candidates found the first correct answer (option B), having understood the phrase quiero que más jóvenes hagan ballet, but the statement algunos piensan que es cuestión de suerte led many to select option A instead. A reasonable number of candidates found the second correct answer (option E), having identified the phrase estoy haciendo vídeos para las redes sociales en los que intento dar a conocer este mundo. Option D was a common wrong answer.

## Key messages

To maximise their chances of success on this paper, candidates should:

- ensure that they answer the question asked and avoid giving additional information that is not required
- bear in mind that answers in the first person in Questions 4 and 6 are unlikely to be correct
- aim to attempt all questions, as there are some questions which are designed to be accessible to the whole ability range. Leaving questions blank offers no chance of scoring a mark.
- remember that the questions follow the order of the text
- plan their time carefully so that they have enough time to deal with the longer, more demanding questions, and allow time at the end to check their answers or check them as they work through the paper.


## General comments

Many candidates demonstrated a good level of understanding of the texts and attempted all the questions.
In the exercises which required short written answers, the best responses were those which were concise and focused on the precise piece of information required to answer the question. Weaker responses included whole sentences which were copied from the text, and this often resulted in inappropriate information being included in the answer, and the mark could therefore not be awarded.

Candidates need to be unambiguous in their answers and be able to correctly manipulate verbs, personal pronouns and possessive adjectives in order to make their answers clear.

Candidates who have a wide range of vocabulary and are able to recognise synonyms will be well equipped to tackle the exercises in this paper, in particular Question 5.

Candidates who can correctly recognise interrogatives usually provide more appropriate answers.

## Comments on specific questions

## Question 1

In this question, candidates needed to match short sentences in Spanish with the correct picture. All pictures and sentences were related to items of clothing and accessories. Candidates need to remember that one of the pictures is surplus to requirements. In general, candidates attempted all questions, and many gained full marks. Many candidates knew bolso and were able to link it with option $\mathbf{B}$, but $\mathbf{C}$ and $\mathbf{E}$ were common incorrect answers. Many candidates understood the word vestido and chose $\mathbf{C}$, but $\mathbf{F}$ and $\mathbf{E}$ were common incorrect answers. Most candidates correctly linked chaqueta with A, but B and C were common incorrect answers. Almost all candidates knew pantalón corto and camiseta.

## Question 2

In this question, candidates read five sentences in Spanish and needed to match each sentence with the correct option from eight signs/notices that could be found in a school. In general, candidates attempted all the questions, and many gained full marks. Most candidates were able to link jugar al baloncesto with the noun gimnasio. The best candidates were able to link hambre y sed with comedor, but there was a range of incorrect answers seen here. Almost all candidates linked libro with biblioteca, and química with laboratorios. A few candidates struggled to match pintura with aula de dibujo; option $\mathbf{C}$ was the most common incorrect answer in this case.

## Question 3

Candidates read a text about sports and answered a set of seven multiple-choice questions, each of which had three options. In most cases, candidates answered all the questions, and many gained full marks.

Question 3(a): Most candidates were able to link 15 años in the text with option $\mathbf{A}$ (un adolescente). A few chose option C (un niño), perhaps because they did not understand the meaning of adolescente.

Question 3(b): Most candidates were able to link the verb nadar in the text with the noun la natación in option B.

Question 3(c): Almost all candidates understood that Alberto trained on sábados and therefore selected los fines de semana (B).

Question 3(d): The best candidates knew that entenderse and Ilevarse bien were synonymous and therefore chose A. Option $\mathbf{C}$ was a common incorrect answer.

Question 3(e): Candidates needed to infer that if puedes hacerte daño then the sport is peligroso (option C). Candidates needed to read the question carefully and not be distracted by Alberto's personal opinion.

Question 3(f): With careful reading of the text most candidates were able to link en un pueblo a tres horas de aquí in the text with en otro pueblo (option C). Option B was a common incorrect answer, but cerca de su casa was where Alberto trained, not where the match was to be played.

Question 3(g): Candidates needed to link vamos a celebrarlo con pizza in the text with comer con sus compañeros (option B). Quite a few candidates were distracted by casa del capitán in the text and chose C, ignoring the mention of pizza. There were also a number of candidates who thought that as the whole team would be celebrating (vamos a celebrarlo), the obvious place would be discoteca (option A).

## Question 4

In Question 4 candidates are required to answer questions on a longer text, which in this case was a letter from Lucía about her barrio. Candidates were required to write short responses in Spanish. The text was written in the first person; candidates needed to take care to change the first person to the third person when required in order to make their answers unambiguous. Many of the answers could be answered with a precise lift from the text, but responses needed to be succinct and unambiguous in order to demonstrate sufficient comprehension.

Question 4(a): This was the most straightforward question in this exercise, with most candidates writing simply 10 años. Some candidates misunderstood the meaning of tiempo in the question and offered the incorrect answer hizo tanto calor.

Question 4(b): Many candidates were able to lift (porque ahora) la gente va a los grandes supermercados directly from the text, but weaker candidates omitted la gente or wrote only grandes supermercados, which did not include enough information to answer the question adequately.

Question 4(c): The best candidates were able to succinctly lift la cafetería from the text, but many candidates lifted too much and included vamos a perder....

Question 4(d): Most candidates identified the correct section of the text from which to draw their answer. Many answered with el dueño es simpatico, but this did not answer the question fully. A two-word answer (el dueño) was sufficient here.

Question 4(e): Many candidates struggled here, blaming the ice cream for Lucía's lack of money. The answer could be lifted straight from the text as the imperfect first-person singular and imperfect third-person singular of the verb haber is the same conjugation (habia olvidado la cartera). Some candidates lifted too much and demonstrated a lack of understanding (cuenta de que...); other candidates did not lift enough, omitting había from their answer. The words olvidado and cartera were frequently spelt incorrectly but the spellings offered were usually minor enough that the answer could still earn credit.

Question 4(f): The answer should have been straightforward and could have been transferred unchanged from the text los días en los que llueve mucho. Mucho was needed here to gain the mark. A complete misunderstanding of what the question was asking, or a misinterpretation of the verb llueve led to los días en los que Marta lleva mucho and en los que llevo mucho.

Question $4(\mathrm{~g})$ : This was a question that required two answers. Most candidates were able to locate the correct responses in the text, but many struggled to manipulate the verbs in order to produce appropriate answers that earned credit. For one answer, the best candidates were able to change pusimos to the thirdperson plural and answer with pusieron una queja or put the verb in the infinitive (poner...). For the other answer, only the very best candidates were able to answer successfully. Candidates needed to manipulate the perfect tense of hemos escrito from the first to the third-person plural (han escrito al periódico). The use of the infinitive escribir... was also accepted.

Question 4(h): The answer required both 50 metros and la plaza linked appropriately (e.g. 50 metros de la plaza). Writing la plaza on its own gave the wrong information. Some candidates were distracted by el centro.

Question 4(i): All that was needed here was one word (medianoche). In general, candidates located the correct part of the text, but many included too much in their answer (e.g. desde las siete de la mañana hasta medianoche). Others recognised the need for a time, but wrongly selected las siete de la mañana.

Question 4(j): Aire acondicionado was the correct response here but many candidates got confused and instead wrote calefacción.

Question 4(k): Candidates could lift un autobús se rompió directly from the text, but some candidates did not fully understand the question and instead looked for a synonym for las altas temperaturas, answering hizo tanta calor.

## Question 5

Candidates were required to match a series of eight descriptions with the requirements and interests of five different people looking for appropriate holiday accommodation. There were therefore three descriptions that were surplus to requirements. Candidates needed to process a range of information and look for the best-fit accommodation for each person. Candidates with a wide range of vocabulary and knowledge of synonyms tended to perform better in this exercise than those whose range of vocabulary and knowledge of synonyms was less well developed. In general, there was a good response to this question.

Question 5(a): This was the question that was answered best in this exercise. Most candidates correctly selected option $\mathbf{5}$, having linked infantiles with niños and having made the connection between sitio seguro and seguridad.

Question 5(b): In order to select the correct answer (option 6), candidates needed to link la montaña with los Pirineos, escalada with alpinismo and en solitario with sola.

Question 5(c): This was the question that was answered least well in this exercise. Candidates needed to link unas vacaciones ... tranquilas with tranquilidad and unas vacaciones económicas with un descuento in option 1. Candidates needed to read the texts carefully to fully grasp the references to age and location.

Question 5(d): Candidates who scored the mark here were able to identify the references to the location, cost and food in option 2, successfully linking caro with lujoso, un sitio de playa with vistas al mar and comida with todo incluido: desayuno, almuerza y cena.

Question 5(e): Many candidates were able to select the correct response (option 8) by linking un país hispano with Argentina and the reference to estudiar la lengua with escuela de idiomas.

## Question 6

Candidates were required to answer questions on a longer, more demanding text about work experience. Candidates were required to write short answers in Spanish. Responses need to be precise and unambiguous. Verbs, personal pronouns, and possessive adjectives needed to be correctly manipulated.

Question 6(a): This was the question that was answered best in this exercise. Most candidates located the correct part of the text for both responses. For one answer, candidates could answer succinctly (turismo) and did not need to add any extra information. Weaker candidates tended to copy indiscriminately in the hope of including the correct answer in their response. For the other answer, many candidates gave the correct response un curso de recepcionista. Weaker candidates often included hice, which invalidated their answer.

Question 6(b): To gain the mark candidates needed to eliminate the word yo from the middle of the sentence so that their answer was in the third person (no les importaba si no iba a clase). The word yo could be substituted by ella, or simply omitted.

Question 6(c): Most candidates identified the correct section of the text, but many could not make the connection between sueño in the question and dormir in the passage. The correct response was no había podido dormir la noche anterior, but common incorrect answers included lo mucho que necesitaba un café or tenía que llevar un uniforme.

Question 6(d): Only the best candidates were able to answer this question correctly. Most candidates understood the interrogative ¿quién? and therefore knew that the answer would be a person. Una compañera was the correct answer; common incorrect responses were su jefa, el otro recepcionista and José.

Question 6(e): Most candidates were able to locate the correct part of the text and the best candidates were able to carefully lift tenía que hacer una llamada urgente. The answer needed to make it clear that José was making (not receiving) an urgent call. The response una llamada urgente was not sufficient here to gain the mark.

Question 6(f): Most candidates understood the interrogative ¿de dónde? and responded with a country or nationality. The best candidates were able to change irlandés in the text to Irlanda, but irlandés was also accepted. There was a wide variety of spellings, most of which were not accurate enough to be earn credit. Some candidates offered Estados Unidos as a response despite there being no mention of the USA in the text.

Question $\mathbf{6 ( g )}$ : This was the question that was answered least well in this exercise. Candidates needed to change the verb me alegro from the first to the third person (se alegra). The responses alegre and le alegra were also accepted.

Question 6(h): Most candidates located the correct answer in the text but only the best candidates could manipulate the verb correctly from the first to the third person (momentos en los que sabe qué hacer). Candidates needed to select carefully from the text and only include the necessary information.

Question 6(i): Almost all candidates located the correct part of the text for both responses. For one answer, candidates needed to either change the verb into the third person (dirigirá al equipo de recepcionistas) or use the infinitive (dirigir). The most common reason for the mark not being awarded was because the verb used in the answer was in the first person (dirigiré...). For the other answer, many candidates correctly lifted comprar su propio hotel from the text. Some candidates invalidated their answer by including me encantaría. There were some instances where candidates were unsure of the meaning of propio, with un propio hotel being a common response.

## SPANISH (Foreign Language)

## Paper 0530/22 <br> Reading

## Key messages

To maximise their chances of success on this paper, candidates should:

- ensure that they answer the question asked and avoid giving additional information that is not required
- bear in mind that answers in the first person in Questions $\mathbf{4}$ and $\mathbf{6}$ are unlikely to be correct
- aim to attempt all questions, as there are some questions which are designed to be accessible to the whole ability range. Leaving questions blank offers no chance of scoring a mark.
- remember that the questions follow the order of the text
- plan their time carefully so that they have enough time to deal with the longer, more demanding questions, and allow time at the end to check their answers or check them as they work through the paper.


## General comments

Many candidates demonstrated a good level of understanding of the texts and attempted all the questions.
In the exercises which required short written answers, the best responses were those which were concise and focused on the precise piece of information required to answer the question. Weaker responses included whole sentences which were copied from the text, and this often resulted in inappropriate information being included in the answer, and the mark could therefore not be awarded.

Candidates need to be unambiguous in their answers and be able to correctly manipulate verbs, personal pronouns and possessive adjectives in order to make their answers clear.

Candidates who have a wide range of vocabulary and are able to recognise synonyms will be well equipped to tackle the exercises in this paper, in particular Question 5.

Candidates who can correctly recognise interrogatives usually provide more appropriate answers.

## Comments on specific questions

## Question 1

In this question, candidates needed to match short sentences in Spanish with the correct picture. All pictures and sentences were related to music and musical instruments. Candidates need to remember that one of the pictures is surplus to requirements. In general, candidates attempted all questions, and most gained full marks. Some candidates did not know batería; option A was a common incorrect answer. There were no other issues in this exercise. There were no other particular issues in this exercise, as almost all candidates understood the phrases escucho música en mi dormitorio, el piano, la música clásica and me gusta leer revistas de música.

## Question 2

In this question, candidates read five sentences in Spanish and needed to match each sentence with the correct option from eight signs/notices that could be seen while shopping in a department store. Most candidates attempted all the questions, and many gained full marks. Many candidates were able to link a mi hermano le regalaré un balón with juguetería, and tengo que comprar lapices para el colegio with papelería. Some candidates struggled with Question 2(c), which tested una máquina de café. Weaker candidates tended to choose either option C (informática), D (muebles) or $\mathbf{F}$ (maquillaje) rather than option $\mathbf{H}$ (electrodomésticos). Almost all candidates were able to find the correct matches for sandalias and falda elegante.

## Question 3

Candidates read a text about a sibling going to university and answered a set of seven multiple-choice questions, each of which had three options. In most cases, candidates answered all the questions, and many gained full marks. Where errors did occur, this was most usually because candidates had not read the text carefully enough, and sometimes relied on what they thought they knew about life in general rather than on what was written in the text.

Question 3(a): Most candidates read the text carefully and were able to work out that the answer was B (tres meses). Some candidates chose A (tres semanas), possibly because of the reference to Navidad and the idea (drawn from personal experience) that Christmas holidays can often be three weeks long. Other candidates chose $\mathbf{C}$ (tres años), perhaps because of the reference to universidad and the fact that university courses often last three years.

Question 3(b): This was the question that was answered best in this exercise. Almost all candidates linked biología in the text with the correct answer A (las ciencias).

Question 3(c): The candidates who recognised charlar and hablar as synonymous were able to choose the correct answer (B). Those who did not differentiate between jugando al tenis and ve deporte opted for $\mathbf{C}$.

Question 3(d): Many candidates were able to link $\mathbf{C}$ (ropa de invierno) with el abrigo in the text. There was a reference to maletas in the text which tempted some candidates into choosing $\mathbf{B}$. The phrases casi se le olvidó el abrigo and le hará falta were structures that some candidates did not know.

Question 3(e): There was a mixed response to this question. Candidates needed to make the link between portátil in the text and ordenador in option C. Option B (móvil) was a common incorrect answer.

Question 3(f): Almost all candidates were able to make the connection between las redes sociales in the text and option B (utilizará Internet).

Question $3 \mathbf{( g )}$ : Candidates needed to read the text very carefully in order to choose the correct answer (A). Quite a few candidates were tempted by the reference to América Latina in the text, to the extent that they did not read to the last sentence, and therefore chose $\mathbf{B}$.

## Question 4

In Question 4 candidates are required to answer questions on a longer text, which in this case was a blog by Héctor about a community magazine. Candidates were required to write short responses in Spanish. The text was written in the first person; candidates needed to take care to change the first person to the third person when required in order to make their answers unambiguous. Many of the answers could be answered with a precise lift from the text, but responses needed to be succinct and unambiguous in order to demonstrate sufficient comprehension.

Question 4(a): Most candidates understood the interrogative ¿dónde? and therefore knew that the answer would be a place. The majority wrote (en) las afueras, although a few candidates changed the preposition en to a; this was accepted. If candidates also included de la ciudad in their response, the word ciudad needed to be spelt correctly (cuidad means something different and therefore could not be rewarded).

Question 4(b): This was the question that was answered best in this exercise, with most candidates writing the succinct answer una fábrica. Many candidates took the verb se veía from the question and used it effectively in their response.

Question 4(c): Many candidates read the question carefully and understood the information that they needed to provide (e.g. poca gente participaba en actividades (organizadas)). Some candidates missed the significance of the end of the question (que comentaron los vecinos) and the link to me dijeron que... in the text, and therefore wrote llegaron de todas partes, y no se conocían.

Question 4(d): Most candidates understood the interrogative ¿cuándo? and therefore knew that the answer would be a time phrase. Many candidates wrote el día después de la conversación, which was too vague. The response needed to contain con los vecinos in order for the mark to be awarded.

Question 4(e): Candidates understood the interrogative ¿quién? and were able to locate the correct person in the text. The best candidates could manipulate the possessive pronoun from mi to su mejor amigo or change the response to el mejor amigo de Héctor. Weaker candidates were unsure how to form the possessive and anglicised responses such as Hectors mejor amigo were common.

Question 4(f): Candidates could simply lift representan el futuro directly from the text. Many weaker candidates copied too much and did not manipulate nuestro barrio. In general, weaker candidates did not cope well with the switch from los jóvenes in the text to la gente in the question, struggling to choose an appropriate verb.

Question 4(g): Candidates could write the succinct answer el nombre. Despite only having one line available for the answer some candidates copied the whole of the last sentence of the second paragraph. Quite a few did not recognise that the interrogative was actually ¿qué?, not ¿cuándo?.

Question 4(h): Candidates needed to recognise how the friends felt; the correct answer was decepcionados. Many added a verb either from the question or the text, but not all made it reflexive. Weaker candidates retained nos quedamos from the text, which invalidated the response. Not all candidates recognised that this question was asking them to identify a feeling, so there were several responses which explained the unsatisfactory results of the photocopier and the cost of improving quality.

Question 4(i): All that was needed to answer this question was the word publicidad. Most candidates located the correct part of the text, but many kept the verb in the first-person plural (deberíamos); others copied parts of the last sentence of the third paragraph.

Question 4(j): Candidates needed to fully understand the question and read the text carefully in order to produce the answer (los exámenes or los exámenes se acercaban). Reference to costó muchísimo trabajo was not accepted on its own without referring to the imminent exams.

Question 4(k): This was the question that was tackled least well in this exercise. Most candidates located the correct responses in the text, but many struggled to manipulate the verbs correctly or provided answers that were too ambiguous for the mark(s) to be awarded. For one answer, candidates needed to change aprendimos in the text to the third person (aprendieron mucho or aprendió mucho). Only the best candidates were able to make the necessary change to the verb here. For the other answer, only the very best candidates gave an acceptable response. Candidates could lift los lectores se divirtieron (leyendo) directly from the text, but many weaker candidates included lo que escribimos or, if they did manipulate the verb escribir correctly, they forgot to specify a subject.

## Question 5

Candidates were required to match a series of eight descriptions with the requirements and interests of five different people who wanted to buy a car. There were therefore three descriptions that were surplus to requirements. Candidates needed to process a range of information and look for the best-fit car for each person. Candidates with a wide range of vocabulary and knowledge of synonyms tended to perform better in this exercise than those whose range of vocabulary and knowledge of synonyms was less well developed. In general, there was a good response to this question.

Question 5(a): This question was the one that was answered best in this exercise, with most candidates correctly selecting option 4. Candidates made the link between rápidamente and rápido, and understood the references made to the opinion of others.

Question 5(b): In order to select option 6 candidates needed to understand the references to where the car would be going, how many people would be in it and how much luggage and equipment it needed to contain.

Question 5(c): Candidates needed to read the texts carefully to fully understand the references to the size of the car, the parking requirements and the effect on the environment in order to select the correct answer (option 1).

Question 5(d): There was a mixed response to this question. The best candidates were able to link grande with espacioso, and daño ... al medioambiente with sin contaminar in option 3.

Question 5(e): In order to select option 8, candidates needed to link barato with precio bajo and understand the references to the age, size, and reliability of the vehicle.

## Question 6

Candidates were required to answer questions on a longer, more demanding text about a dancer. Candidates were required to write short answers in Spanish. Responses need to be precise and unambiguous. Verbs, personal pronouns, and possessive adjectives needed to be correctly manipulated. It was clear that many candidates had a good understanding of the text, but they were not always able to communicate their understanding of the text precisely and accurately.

Question 6(a): Candidates needed to change the order of the text in order to be able to respond correctly (guarda la bicicleta (en el jardín)). Some candidates were tempted into copying Raúl la guarda en el jardín, which was meaningless as a response when it stood independently from the text. Other candidates made reference to la casa que comparte con sus padres y su hermana, clearly misunderstanding the question.

Question 6(b): Many candidates encountered difficulty here. The correct response was se pasaba el día bailando or a reference in the past tense of Raúl loving to dance; encantaba bailar was preferred but encantó bailar was also accepted. Those who responded in the present tense (Raúl le encanta bailar) could not be rewarded, nor could those who did not manipulate regalamos into the third-person plural correctly. Some candidates omitted too much (e.g. Raúl bailando por la casa) and therefore could not earn the mark, nor could those who retained sino in their response (sino pasaba el día bailando por casa).

Question 6(c): Candidates who understood the question identified that the response should contain an emotion and responded concisely with miedo. Those who extended their answer needed to change the pronoun from mí to él or Raúl (i.e. tenía miedo de que los niños se rieran de él/Raúl). The candidates who did not fully understand the question usually referred to clase de hip-hop.

Question 6(d): Most candidates understood the interrogative ¿a quién? and found their way to the answer bailarines, but the difficulty lay in making clear which dancers. The response had to make a link with London (e.g. los bailarines (de la escuela) de Londres). The reference to London was often omitted, which left the response ambiguous and therefore unable to attract credit.

Question 6(e): Candidates needed to read the question carefully in order to find the answer sonrisa. Many lifted suya sonrisa, which did not answer the question. Weaker candidates who did not understand the question thought that física referred to physical or physicality without making the link to appearance and consequently there were several responses referring to gymnastics (con sesiones de gymnasia).

Question 6(f): This was the question that was answered best in this exercise. Candidates generally located the correct part of the text for both responses, and concision was a good strategy when responding. For one answer, candidates could write the succinct answer gimnasia and did not need to include any extra information. For the other answer, idiomas or inglés was the required response, and many candidates succeeded here. If they copied more from the text, they needed to be precise because le hicieron un examen de idiomas was acceptable whereas hicieron ... was not. Some candidates referred to mostrar su talento para el baile or su educcación será en inglés, which did not answer the question.

Question 6(g): Many candidates responded correctly with va (francamente) mal en sus clases. The verb form iba was also accepted here and en inglés could be substituted for en sus clases. Errors usually occurred when manipulating the verb voy, which was often changed from ir to ser, and sometimes estar.

Question 6(h): There were many good answers here. La misma oportunidad que Raúl was the most common correct response rather than que él. There were a few examples of responses containing que su, which could not be rewarded. Some candidates chose to be more specific (e.g. la oportunidad de irse a/estudiar en una ciudad extranjera).

Question 6(i): In general, candidates located the correct part of the text for both answers, and many answered both parts correctly. For one answer, there were two possible approaches: candidates could either write le gusta el instituto or prefieren/quieren que no deje el instituto. Weaker candidates tended to keep nuestro pueblo from the text or had difficulty changing preferimos to prefieren. The word quieren could be lifted from the question. For the other answer, candidates could lift ella está teniendo éxito en la equitación directly from the text. If candidates referred to the horse in their answer, then the reference needed to be accurate because they could not lift con el caballo que temenos without modification.

Most candidates attempted all the questions, and many gained full marks. Many candidates were able to link dejar el coche with the noun aparcamiento para visitantes, but there was also a range of incorrect answers given. The best candidates were able to link tienda with comprar regalos y recuerdos, but some candidates gave $\mathbf{H}$ (ascensores) as their answer. Almost all candidates were able to find the correct matches for vestidos y trajes, hambre and no se permite hacer fotos ni vídeos.

## Question 3

Candidates read a text about holidays and answered a set of seven multiple-choice questions, each of which had three options. In most cases, candidates answered all the questions, and many gained full marks.

Question 3(a): Most candidates were able to link soy camarera en una cafetería in the text with va a trabajar in option $\mathbf{C}$. The most common incorrect response was $\mathbf{A}$, despite there being no mention of amigos in the text.

Question 3(b): Most candidates chose the correct answer B (primas). The most common incorrect answer was $\mathbf{A}$ (padres), which was mentioned in the following sentence in the text.

Question 3(c): Candidates needed to link the noun natación in the text with the verb nadar in option A. A few candidates struggled here.

Question 3(d): Almost all candidates chose the correct answer C (hace sol).
Question 3(e): With careful reading of the text most candidates were able to select the correct response (B).
Question 3(f): Most candidates chose the correct answer B (bocadillos), which was mentioned in the text.
Question 3(g): This was the question that was answered best in this exercise, with most candidates selecting the correct response (C).

## Question 4

In Question 4 candidates are required to answer questions on a longer text, which in this case was a blog by Javier about el tenis de mesa. Candidates were required to write short responses in Spanish. The text was written in the first person; candidates needed to take care to change the first person to the third person when required in order to make their answers unambiguous. Many of the answers could be answered with a precise lift from the text, but responses needed to be succinct and unambiguous in order to demonstrate sufficient comprehension.

Question 4(a): Most candidates located the answer in the text and lifted tenía que ayudar en la granja. The best candidates were able to manipulate donde vivíamos into the third-person plural (vivían), but if they left it in the first-person plural then the mark could not be awarded.

Question 4(b): Many candidates lifted en el hotel directly from the text, but weaker candidates also included donde nos alojábamos which invalidated the response. If they transformed the verb into the third-person plural (se alojaban), the mark was awarded.

Question 4(c): The best candidates lifted just abuelo from the text, which was the most succinct answer, but many candidates included mi, which invalidated the answer, or just wrote padres, which was incorrect. The best candidates were able to change the possessive pronoun to su.

Question 4(d): Most candidates understood what information was required by the interrogative ¿a qué edad?. The answer was simply 14 años, but weaker candidates tended to lift too much from the text and invalidated their response.

Question 4(e): This question was not answered particularly well. To gain the mark candidates needed to write entre octubre y mayo; many omitted the word entre from their response and this produced an answer with a completely different meaning, so the mark could not be awarded.

Question 4(f): This was the question that was answered best in this exercise. Most candidates answered succinctly (verde or la camiseta es verde). Any reference to the first person here was unacceptable.

Question 4(g): Most candidates were able to locate the correct part of the text, and the best candidates were able to manipulate the verb tener into the third-person plural and produce the answer tienen personalidades diferentes. Some candidates retained tenemos in their response, and others wrote es genial formar parte de un equipo from the preceding sentence, neither of which could be rewarded.

Question 4(h): Most candidates located the correct answers in the text and wrote good responses. Candidates could not be awarded the mark(s) if they lifted too much information from the text and/or included no solo ... sino que in either response. For one answer, candidates could lift es un deporte muy barato directly from the text (or, more succinctly, es barato). For the other answer, candidates could lift no necesitas practicar todos los días directly from the text.

Question 4(i): Candidates needed to manipulate the verb cenar from the first-person plural cenamos to either the third-person singular cena or the third-person plural cenan, or use the infinitive cenar. Candidates could also include algo juntos in their responses, but this was not essential in order for the mark to be awarded.

Question 4(j): Most candidates located the answer in the text, and the best candidates were able to change the first-person verb duermo to the third person duerme.

Question 4(k): Candidates only needed to write one word (nervioso) in order to answer this question accurately. Weaker candidates tended to retain estoy in their response, or copied too much from the text, so could not be rewarded.

## Question 5

Candidates were required to match a series of eight descriptions with the requirements and interests of five different people regarding holiday plans. There were therefore three descriptions that were surplus to requirements. Candidates needed to process a range of information and look for the best-fit holiday for each person. Candidates with a wide range of vocabulary and knowledge of synonyms tended to perform better in this exercise than those whose range of vocabulary and knowledge of synonyms was less well developed. In general, there was a good response to this question.

Question 5(a): This question required candidates to fully understand the references to lack of funds and the need for descanso total with the cost and description of location in option 3.

Question 5(b): In order to select the correct answer (option 8), candidates needed to link le interesan los animales with pájaros y monos and make the connections between the cost, location and accommodation.

Question 5(c): This question was the one that was answered best in this exercise, with most candidates linking un sueldo with ganar dinero and therefore selecting the correct answer (option 7).

Question 5(d): Those who scored the mark here identified the references to the location and to the desire to meet people, and therefore selected option 1.

Question 5(e): Candidates who got this question right linked aprender cosas nuevas with clases de pastelería and clases de idiomas, and therefore chose option 2. There was also Carolina's reference to being unable to drive which could be linked with the offer of transport to and from the airport.

## Question 6

Candidates were required to answer questions on a longer, more demanding text about a local tradition. Candidates were required to write short answers in Spanish. Responses need to be precise and unambiguous. Verbs, personal pronouns, and possessive adjectives needed to be correctly manipulated.

Question 6(a): Candidates needed to read the question and the text carefully in order to find the answer el primer domingo de abril. Candidates could not be rewarded if they merely lifted el primer domingo de este mes from the text, as the answer needed to be more precise and include abril. Another common incorrect answer was esta fiesta se celebra desde hace 25 años.

Question 6(b): Most candidates recognised that the interrogative ¿quién? meant that the answer would need to be a person. The phrase unos trabajadores del ayuntamiento could be lifted directly from the text, but candidates who omitted del ayuntamiento could not score the mark. Several candidates wrote los dueños de negocios from the following sentence, which could not be rewarded.

Question 6(c): Most candidates identified the correct section of the text, but many responded with por esas calles de la ciudad rather than las calles del centro. Other candidates added extra information which then invalidated their response.

Question 6(d): In general, candidates located the correct part of the text for both responses but only the stronger candidates were precise enough to score the marks. For one answer, candidates could lift traer comida para compartir from the text, but they needed to be precise and eliminate any erroneous material. The inclusion of para compartir was essential in order to gain the mark. For the other answer, candidates again needed to be precise with the lifting of evitar usar vasos o platos de plástico. Some candidates copied too much, whilst others omitted the word evitar and therefore gave an answer that meant something completely different from what had been communicated in the text.

Question 6(e): Candidates needed to manipulate the verb saber from the imperfect first-person plural in the text to the third person (no sabían cuántas personas vendrían). The present tense was not accepted in this response to this question.

Question 6(f): Many candidates encountered difficulty when changing the first person estuve enfermo to the third person estuvo enfermo. Candidates who included additional information also had to transform it into the third person (...y se puso triste).

Question 6(g): Most candidates located the answer in the text, but this then had to be converted to the third person (va a traer la/su guitarra y tocarla (para todos)). Responses including the first person were not rewarded, and some responses did not contain enough information for the mark to be given.

Question 6(h): There was a mixed response to this question. Candidates needed to change the direct object pronoun from me to la (i.e. la ha invitado una compañera). Responses with the indirect object pronoun le were also accepted.

Question 6(i): This was the question that was answered best in this exercise. For one answer, candidates could lift reservar mesa pronto directly from the text. Responses including recomendó could not be rewarded. For the other answer, candidates could simply lift zapatos cómodos. Weaker candidates often included me aconsejó in their response, which prevented the mark from being awarded.

# SPANISH (Foreign Language) 

Paper 0530/03<br>Speaking

## Key messages

- Examiners should familiarise themselves with the scripts for both the role plays and the topic conversations before conducting any live speaking tests. They must adhere to the scripts as set out in the instructions for teachers/examiners booklet.
- At the start of each candidate's test, the examiner should greet the candidate using the prompts provided and set the scene for the role play by reading out the role play scenario. The examiner should select the appropriate form for their role, e.g. in role play 1 the examiner needed to say either Yo soy el profesor or Yo soy la profesora (rather than saying Yo soy el profesor/la profesora).
- In the topic conversations, examiners should always make use of the scripted alternative questions when candidates are unable to provide a response to the main question.
- In the topic conversations, examiners should be prepared to use extension questions. If candidates answer briefly, examiners can encourage a fuller response by asking extension questions or prompts such as Háblame un poco más sobre..., ¿Qué más me puedes decir sobre...?, ¿Puedes decirme algo más (sobre eso)?. The extension questions give candidates the opportunity to develop their ideas and provide justifications, opinions and explanations so that they can demonstrate their command of a range of more complex language and structures.
- In the interests of fairness to all candidates, examiners should adhere to the timings for the two topic conversations. If the topic conversations last $31 / 2$ minutes or less, examiners should use up to two open-ended further questions, on the same topic, to make sure the conversations last 4 minutes. They should not repeat previous questions that they have already asked earlier in the conversation or use the alternative questions as further questions.
- Candidates should be encouraged to learn (and know how to use accurately) a range of verb forms, particularly the present, past and future. Equally, candidates should ensure that they know a good range of vocabulary relating to the various topics listed in the syllabus.


## General comments

To be read in conjunction with the instructions for teachers/examiners booklet (June 2021).
Most centres sent the correct sample size for moderation and the quality of the recordings was generally good. Centres are responsible for ensuring the quality of recordings and it is essential that centres check this prior to despatching them to Cambridge International.

Examiners must follow the randomisation instructions provided when allocating role plays and topic conversations to candidates.

Each sample that you submit to Cambridge International must contain a recorded introduction. This should include the centre number, the centre name, the syllabus and component number, the syllabus name and the exam series/year (e.g. June 2021). At the start of the test, and after pressing 'record' on the recording equipment, the examiner must announce their own name, followed by the candidate's number and name, the role play card number and the date on which the speaking test is taking place. Each recorded file in the sample must be named clearly using the following convention:
centre number_candidate number_syllabus number_component number
Examiners are reminded that once a speaking test has started, the recording must run without interruption and must not be stopped or paused at any point during the test.

In general, the working mark sheets were completed correctly. Examiners need to remember to enter the candidate name, candidate number, role play card number and topic conversation numbers in the appropriate places, and to write a mark in each column. The name of the examiner needs to be legible.

The majority of centres assessed their candidates fairly. All assessment should follow the marking criteria as set out in the instructions for teachers/examiners booklet. Examiners should be consistent in their marking. Marking should be positive, rewarding achievement.

## Comments on specific questions

## Role Plays

The nine role plays were all set in situations in which candidates could find themselves in real life. The first two tasks in each role play were of a factual nature and gave candidates the opportunity to answer briefly. Short responses to tasks 1 and 2 were perfectly acceptable. The last three tasks gave candidates the opportunity to give longer responses. The majority of candidates coped well with the role plays, with most candidates able to use appropriate vocabulary and a variety of tenses correctly.

Examiners generally conducted the role plays well. However, a few examiners omitted to ask the second element of a task, thereby limiting the maximum mark that could be awarded for the task overall. In cases where candidates do not answer a question, examiners can repeat the question once, but they must not rephrase it. In the role plays, candidates should focus on communicating the information sought rather than on providing very lengthy responses.

Most examiners assessed their candidates well in the role plays, although a few were either too generous or too severe. Sometimes candidates were awarded full marks for responses that were in an incorrect timeframe, or which had an incorrect subject of the verb. On the other hand, a number of candidates were too heavily penalised when they only committed minor errors that did not impede or confuse the message that they needed to transmit.

Role play 1: Some candidates responded to task 4 without using the imperfect tense. In task 5 , almost all candidates were able to explain why they wanted to do their chosen course.

Role play 2: Nearly all candidates answered all tasks in the correct timeframe. Some candidates struggled with task 2. Rather than communicating a country, they instead gave their nationality. Occasionally, the second element of task 3 was misinterpreted. Candidates assumed that they were being asked how many days they had already spent in Panama, rather than the duration of their stay. A number of candidates required repetition of the second element of task 4. A few candidates struggled to provide a reason for their choice of activities in task 5.

Role play 3: The majority of candidates completed this role play well. In task 3, some candidates initially did not understand the word recoger and required repetition in order to be able to provide a response.

Role play 4: Most candidates tackled this role play confidently. When responding to task 1 , many candidates responded with reference to the currency of their country of residence, rather than euros. This was not penalised.

Role play 5: This role play was generally completed well. Some candidates were hesitant when responding to task 3, perhaps because they mistakenly thought that they were required to have an in-depth knowledge of Spanish food in order to respond.

Role play 6: Some candidates struggled to provide appropriate responses to this role play.
Role play 7: A number of candidates struggled with the word tiempo in task 2.
Role play 8: Some candidates struggled to provide an appropriate response to task 4.
Role play 9: A few candidates encountered difficulty when trying to handle the various timeframes of this role play.

## Topic Conversations

Examiners are reminded to introduce the topic area just before they start each conversation. The first three topics were based on one of the sub-topics of Areas A and B as listed in the syllabus. The last four topics were based on one of the sub-topics of Areas $C, D$ and $E$ in the syllabus. All the sub-topics were familiar to candidates and a full range of performance was seen, with each conversation having its easier and more challenging tasks. As in the role plays, the first two tasks in each conversation were more closed and straightforward in nature and were set at an easier level to start off the conversation. They could be answered briefly and with factual language. The final three tasks in each conversation were more open and required candidates to communicate in past and future timeframes. Each topic conversation also gave candidates the opportunity to express opinions and, where appropriate, develop the reasons for their opinions.

The timings of the topic conversations were generally very good, and most examiners adhered to the instructions given in the booklet provided. Sometimes the marks awarded for communication were rather too generous, whereas the marks for quality of language were sometimes too harsh. Candidates do not need to be of native-speaker standard to achieve the highest possible mark. Stronger candidates generally responded confidently to questions and often expanded their responses, even when they were not asked extension questions. Candidates should be encouraged to listen carefully to the timeframe used in the question and to respond accordingly.

It is important that examiners familiarise themselves with the difference between alternative questions (which allow candidates the opportunity to respond when they haven't been able to say anything in response to the main question), extension questions (which the examiner can use within the body of the main topic conversation itself in order to elicit a fuller response from the candidate) and further questions (which the examiner can use in order to ensure that the topic conversation adheres to the timings stipulated in the instructions for teachers/examiners booklet).

Some examiners did not understand how to use the alternative questions. In some cases, the candidate gave a suitable and full answer to the main question, and the examiner then asked the alternative question as well. This was unnecessary because the candidate had already given an appropriate response to the main question. A few examiners overlooked the pauses that were built into the topic conversation scripts, which meant that some candidates didn't have the opportunity to respond to the first element of the task. There were a few instances where examiners appeared reluctant to use the alternative questions, even in cases where use of the alternative questions was allowed and would have benefited the candidate.

On the whole, examiners used extension questions appropriately. Where a task had a second element and this element was ¿Por qué?, some candidates gave a reason when answering the first element of the task. In this case, examiners should be prepared to ask an extension question rather than repeating the second element when candidates have already provided the information sought.

Where examiners asked further questions, these were, in most cases, relevant to the topic.
Topic 1, la televisión y el cine: Most candidates communicated the necessary information well. Many developed their responses and provided plenty of detail.

Topic 2, las vacaciones: In task 5, some candidates did not understand the words ventajas and desventajas, and needed to hear the alternative question (which used the words positivo and negativo instead of ventajas and desventajas) before they could provide an answer.

Topic 3, comer y beber: In general, candidates responded confidently, providing ample detail.
Topic 4, las tradiciones y las fiestas: Generally, this topic was tackled quite well.
Topic 5, los teléfonos móviles: In task 1, some candidates did not understand the word tamaño. A number of candidates needed to have task 2 repeated.

Topic 6, el trabajo: Some candidates struggled to respond to task 3, particularly the first element regarding how they had helped their family.

Topic 7, el mundo natural: The majority of candidates managed to communicate all of the required information. In task 2, some candidates thought that the word tiempo referred to time instead of weather.

# SPANISH (Foreign Language) 

Paper 0530/41<br>Writing

## Key messages

- Candidates should read the initial rubric of each question and each task carefully to ensure that the response that they produce is relevant and includes appropriate tenses.
- In order to ensure that they respond to all the tasks in Questions 2 and 3, candidates may benefit from attempting the tasks in the order in which they appear on the question paper.
- Candidates should recognise the need to use an appropriate range of structures, tenses and vocabulary in their response to Question 3 in order to give themselves access to the full range of marks available. Similarly, they need to develop their answers by including additional information (e.g. explanations, reasons, opinions, etc.).
- Candidates should pay careful attention to the formation of vowels and the placement of accents as these features can affect the marks for the three criteria in Question 3.
- It is recommended that candidates adhere to the word counts for Question 2 and Question 3.


## General comments

Work from the whole ability range was seen. Many candidates performed very well in Questions 1 and 2. In Question 3 stronger candidates showed control of varied sentence structures and verb tenses, and complex linguistic structures were seen, including idiomatic expressions.

Handwriting was an issue in some cases. Candidates need to pay careful attention to their handwriting, particularly when forming vowels.

Candidates also need to plan their time carefully during the examination in order to allow themselves time at the end to check their work.

In Question 1 candidates should always try to produce an answer for each of the five gaps. They need to read the initial rubric carefully, as well as the tasks themselves, so that they can provide appropriate responses. Candidates should avoid writing answers outside the dotted lines provided and, if they need to cross out any rough working, this needs to be done carefully. Extra answers for one task cannot compensate for other tasks that have not been attempted or that are incorrect.

In Question 2, up to 12 marks are awarded based on task completion, relevance, clarity of the message, variety of vocabulary and structures, and the use of linking words. There is no requirement to provide the same amount of information for each of the tasks. Candidates should be reminded that the maximum of 12 marks cannot be awarded if they omit or do not successfully convey at least one detail for each of the tasks, including tasks that include two elements. Candidates are required to write responses in full sentences and to form their response as a piece of prose, rather than as a series of bullet points. Candidates need to produce a recognisable part of an appropriate verb in order to gain credit for task completion. It is acceptable for two tasks to be completed in a single sentence. Candidates need to link their words, phrases and sentences using a range of simple connectors (e.g. y, también, pero, etc.).

Question 3 offers a choice of two options: a letter/email and a report/article. There are 10 marks available for Task Completion, 10 marks for Range and 8 marks for Accuracy. The marks for Range are awarded based on the candidates' ability to extend and link sentences, and the range of tenses and other structures used, as well as the range of vocabulary. Candidates should ensure that they select the question which will allow them to best show the Spanish that they know. Candidates should read through both options before choosing which one to answer. A close reading of the tasks within the questions is recommended as this will allow candidates to think about the vocabulary and structures that they will need to use in order to respond effectively and fully to the question.

Task completion: For a task to be consider complete, candidates must respond to the task using the tense required by the task with the production of a wholly accurate verb. Minor spelling errors might be tolerated, e.g. when a missing accent does not produce another tense which causes ambiguity.

Range: The use of extended sentences, a range of connectives, tenses, varied structures including idioms and vocabulary is required in order to reach the top mark band. When the descriptor states 'uses', it should be read as 'uses successfully'. Candidates who struggle to use basic tenses are likely to achieve a maximum of five marks for Range. Only those who attempt some complex structures are able to access a mark of six or higher for Range.

Accuracy: Candidates do not have to produce a perfectly accurate piece of writing in order to achieve the full 8 marks available for Accuracy. Minor errors which do not impede communication will not be penalised.

When finalising their responses for Question 2 or Question 3, candidates need to be careful if they decide to cross out any parts of their response. There were some instances where crossing-out had occurred, and this affected the coherence and clarity of the piece of writing overall.

## Comments on specific questions

## Question 1: Quieres participar en un curso de deportes durante las vacaciones.

The majority of candidates achieved the full five marks available for this question. Many candidates produced accurate spellings in each of their responses. Minor spelling errors were tolerated as long as the word would be recognised by a native speaker of Spanish. In many cases, minor spelling errors did not prevent the award of marks (e.g. the words avril and marso were accepted in response to task 4). A significant number of candidates confused nacionalidad with país, and wrote answers such as España rather than español in response to task 2. When tackling task 4, many candidates focused on the verb participar and wrote another sport, instead of noticing the word mes and writing a month. Candidates need to remember that the information they give when filling in the form doesn't have to be true; they should use the vocabulary with which they are most confident in order to give them the best chance of scoring the marks.

## Question 2: Mi mejor amigo/amiga

Most candidates were able to use familiar language and structures when responding to Question 2, and many gained full marks here. Candidates who worked methodically through the tasks in order were less likely to omit one of them. Candidates need to address all five tasks adequately in order to access the top mark band, but addressing all five does not automatically guarantee a mark of 12. In addition, those who address all five tasks but in very brief, unlinked sentences are unlikely to be able to achieve the highest marks. The best answers tended to be straightforward but detailed. A common error was not responding in the appropriate tense - careful study of the bullet points would help to avoid this. Minor errors were tolerated but any mistakes that hindered communication did affect the mark; candidates need to try to use language that they are confident with and avoid over-complicating their responses.

In the best answers, candidates used connectors such as también, sin embargo, además, por lo tanto to good effect, as well as opinions starting with phrases such as pienso que, creo que, me gusta, me encanta and odio.

Task 1, which asked candidates provide a physical description of their best friend, was not always tackled successfully. The most common descriptions referred to height, weight and hair/eye colour. Candidates need to be careful with the different verbs required for physical description; some confusion was apparent here, and this often caused the task to be considered incomplete.

Task 2 required candidates to say what activities they usually did with their best friend. The most common responses alluded to sport, but conjugating the verb jugar appropriately caused issues for weaker candidates.

Task 3 required candidates say when they usually spent time with their friend. The phrase pasar tiempo caused issues for weaker candidates, but the majority of candidates made reference to the weekend, holidays or after school. Some stronger candidates made reference to the covid-19 pandemic and the fact that they could not spend time with their friend. Such answers were considered to have addressed the task.

Task 4 required candidates to explain why they get on well with their friend. Many candidates answered this well, often citing sense of humour, shared interests and personality traits as reasons. The verb llevar did cause some confusion.

Task 5, which should have been relatively straightforward, was not addressed adequately by a significant number of candidates, either because they overlooked the verb tense used in the bullet point or because they did not say where they would like to go; many candidates wrote about what they would do, rather than where they would go.

## Question 3: General comments

Most candidates chose Question 3(a). There were some imaginative and engaging responses for both options. Some candidates did not gain as many marks as they could have done because they omitted to cover one or more of the tasks. The most successful answers were well structured and showed signs of thoughtful planning. Both options tended to be answered better when candidates wrote a distinct paragraph for each task. Candidates generally respected the guidelines about length, producing between 130 and 140 words. Some candidates significantly more than 140 words, and this had a negative impact on the marks awarded in some cases because it led to irrelevance or inaccuracy.

## Task completion

In order to obtain high marks for Task completion, candidates need to ensure that they:

- address all of the tasks given in the question
- provide sufficient information relating to each task by expressing a range of details/opinions/ reactions/explanations - one good strategy that candidates can use is to provide at least two full sentences in response to each task
- address the specific tasks set
- use verbs accurately
- use an appropriate tense and person of the verb when responding to each task
- copy accurately when using words provided in the question.


## Range

Many candidates scored well here, displaying an adequate range of structures and vocabulary appropriate to the level. Many candidates had developed good techniques for adding extra details by using conjunctions or extending the content of their responses, and a number used linking words such as porque, así que, por eso and cuando to good effect. Weaker candidates tended to rely on basic structures.

In cases where candidates did not score so well for Range, this was most usually because they used the same devices repeatedly (e.g. only the preterite tense or one particular grammatical structure). Some candidates did not demonstrate their ability to use a range of complex structures and consequently could not be awarded a mark higher than five or six. The stronger candidates made sure to use a wide range of tenses, adding anecdotal, hypothetical and future detail to their original points.

It is important for all candidates to show control of basic structures, including correct spelling and gender.
Access to the higher mark bands is more likely to be achieved through accurate and appropriate use of:

- subordinate clauses introduced by conjunctions, relative pronouns, etc., produced throughout the response (e.g. cuando/donde/mientras (que)/visto que/puesto que/dado que/ya que/que/quien/si)
- appropriate formation of constructions with verbs requiring a preposition (e.g. hablar con, con quien hablé)
- a range of timeframes and first-person and third-person verb forms
- adjectives, possessive adjectives, demonstrative adjectives, comparative/superlative adjectives
- adjectival agreement between the subject and its adjective(s)
- correct use and placement of object pronouns in relation to conjugated verbs and infinitives
- negatives, including appropriate word order (e.g. nada/nunca)
- correct use of por and para
- adverbs, prepositional phrases, time references, opinion markers
- linking words other than $y$, pero and porque
- definite and indefinite articles.

#### Abstract

Accuracy A high level of accuracy is expected for the award of marks in the top band. However, the response does not necessarily have to be faultless in order for such a mark to be given. Responses that contain minor errors (especially in more complex language) which do not affect communication can be considered for the award of marks in the top band. Candidates who planned their responses, in terms of content and language, tended to score better for Accuracy than candidates who did not plan so well. The key is to blend ambition with accuracy: some candidates attempted language that was too ambitious for them, and this had a negative impact on their mark for Accuracy because their attempts at producing more complex language sometimes impeded communication. Candidates need to focus on writing language that they are confident they know, within the confines of the question, rather than necessarily what they want to write.

Frequent inaccuracies will limit the overall mark awarded for Accuracy. Responses which show errors in basic tenses, in adjective-noun agreements and in other basic structures/words are likely to be placed in the 3-4 band, depending on how often these errors hinder communication. Similarly, candidates who produce a very short text using only basic language cannot usually achieve a mark beyond the 3-4 band, since they will only have demonstrated some accurate spelling and grammar. Candidates who persistently struggle with accuracy in very basic language and whose errors persistently impede communication are likely to be placed in the 1-2 band.


## Common errors

The following common errors were seen:

- poor control of tenses
- lack of agreement between the subject and the adjective
- inaccurate use of object pronouns
- lack of personal a after verbs that require it
- inaccurate use of negatives
- poor control of modal verbs
- poor grasp of structures such as tener que, después de, antes de, tener ganas de, decir que, estar harto de, etc.
- insecure grasp of adverbs and prepositional phrases.


## Question 3(a): Los estudios

This was the more popular option.

## Task completion

Task 1 required candidates to state what their favourite school subject was last year. The majority of candidates answered this well, but many overlooked the fact that their answer needed to be in the past, instead saying what their favourite subject currently is.

Task 2 required candidates to describe the last time a teacher helped them. A significant number of candidates encountered difficulty here. Many thought that the task was asking them to describe when they last helped a teacher, leading to many irrelevant responses. A stronger understanding of the preterite would have helped here (not all verbs that end in $o$ are the yo form).

Many candidates addressed task 3 successfully, with a whole range of ideas presented to explain why it was important to learn languages. Common explanations were that it is helpful when travelling, that it is useful to have the ability to communicate with those in another country and that it improves one's chances of finding a job.

Task 4 was a straightforward task, with the majority of candidates stating that they did their homework after school or at the weekend. Some candidates over-complicated their responses here, trying to say things like 'the day after the homework has been set'.

A number of candidates struggled with task 5 as they did not know the phrase sacar buenas notas. This is a relatively common expression when studying the topic of school/education. Many thought that it meant 'to take notes', which led to a number of irrelevant responses.

## Range

The stronger candidates responded to the tasks using idiomatic Spanish. They showed knowledge of vocabulary, grammar and idiom beyond the basic requirements of the tasks. Some good candidates, however, were let down by the lack of range in their language.

## Accuracy

The stronger candidates often used highly accurate Spanish, and their language was succinct and clear, with little impediment to communication.

## Question 3(b): Un regalo

This was the less popular option.

## Task completion

Task 1 was generally answered well, although some candidates did not understand that they had already bought the present. Many candidates opted to write about clothes, cars or books, which were relatively easy to describe with details relating to size and/or colour.

Task 2 required candidates to explain why they had chosen the present. Many candidates encountered difficulty here because of the verb form elegiste, which a significant number could not transform into eligí. Those who did address this task well tended to focus on the hobbies/interests of the recipient, or on the cost.

Task 3, which required candidates to explain why they liked giving gifts, was answered well on the whole, although over-complication of language was again an issue here for some, with (mostly unsuccessful) attempts at things like 'I like to see people smiling'.

Task 4 was relatively straightforward, with the majority of candidates lifting the verb used in the question and adding their ideal gifts such as money, cars, trips and clothes. Some candidates focused on the sentiment behind the gift, which was an original way to interpret this task.

Task 5 was again relatively straightforward, requiring candidates to describe a typical family celebration. Some candidates did not grasp the tense of the question, choosing instead to say what had happened at the birthday party of a family member.

## Range

The stronger candidates responded to the tasks using idiomatic Spanish. They showed knowledge of vocabulary, grammar and idiom beyond the basic requirements of the tasks. Some good candidates, however, were let down by the lack of range in their language.

## Accuracy

The stronger candidates often used highly accurate Spanish, and their language was succinct and clear, with little impediment to communication.

## Key messages

- Candidates should read the initial rubric of each question and each task carefully to ensure that the response that they produce is relevant and includes appropriate tenses.
- In order to ensure that they respond to all the tasks in Questions 2 and 3, candidates may benefit from attempting the tasks in the order in which they appear on the question paper.
- Candidates should recognise the need to use an appropriate range of structures, tenses and vocabulary in their response to Question 3 in order to give themselves access to the full range of marks available. Similarly, they need to develop their answers by including additional information (e.g. explanations, reasons, opinions, etc.).
- Candidates should pay careful attention to the formation of vowels and the placement of accents as these features can affect the marks for the three criteria in Question 3.
- It is recommended that candidates adhere to the word counts for Question 2 and Question 3.


## General comments

Work from the whole ability range was seen. Many candidates performed very well in Questions 1 and 2. In Question 3 stronger candidates showed control of varied sentence structures and verb tenses, and complex linguistic structures were seen, including idiomatic expressions.

In Question 1 candidates should always try to produce an answer for each of the five gaps. They need to read the initial rubric carefully, as well as the tasks themselves, so that they can provide appropriate responses. Candidates should avoid writing answers outside the dotted lines provided. Extra answers for one task cannot compensate for other tasks that have not been attempted or that are incorrect.

In Question 2, up to 12 marks are awarded based on task completion, relevance, clarity of the message, variety of vocabulary and structures, and the use of linking words. There is no requirement to provide the same amount of information for each of the tasks. Candidates should be reminded that the maximum of 12 marks cannot be awarded if they omit or do not successfully convey at least one detail for each of the tasks, including tasks that include two elements. Candidates are required to write responses in full sentences and to form their response as a piece of prose, rather than as a series of bullet points. Candidates need to produce a recognisable part of an appropriate verb in order to gain credit for task completion. It is acceptable for two tasks to be completed in a single sentence. Candidates need to link their words, phrases and sentences using a range of simple connectors (e.g. y, también, pero, etc.).

Question 3 offers a choice of two options: a letter/email and a report/article. There are 10 marks available for Task Completion, 10 marks for Range and 8 marks for Accuracy. The marks for Range are awarded based on the candidates' ability to extend and link sentences, and the range of tenses and other structures used, as well as the range of vocabulary. Candidates should ensure that they select the question which will allow them to best show the Spanish that they know. Candidates should read through both options before choosing which one to answer. A close reading of the tasks within the questions is recommended as this will allow candidates to think about the vocabulary and structures that they will need to use in order to respond effectively and fully to the question.

Task completion: For a task to be consider complete, candidates must respond to the task using the tense required by the task with the production of a wholly accurate verb. Minor spelling errors might be tolerated, e.g. when a missing accent does not produce another tense which causes ambiguity.

Range: The use of extended sentences, a range of connectives, tenses, varied structures including idioms and vocabulary is required in order to reach the top mark band. When the descriptor states 'uses', it should be read as 'uses successfully'. Candidates who struggle to use basic tenses are likely to achieve a maximum of five marks for Range. Only those who attempt some complex structures are able to access a mark of six or higher for Range.

Accuracy: Candidates do not have to produce a perfectly accurate piece of writing in order to achieve the full 8 marks available for Accuracy. Minor errors which do not impede communication will not be penalised.

When finalising their responses for Question 2 or Question 3, candidates need to be careful if they decide to cross out any parts of their response. There were some instances where crossing-out had occurred, and this affected the coherence and clarity of the piece of writing overall.

## Comments on specific questions

## Question 1: Quieres encontrar tu maleta en el aeropuerto.

The majority of candidates achieved the full five marks available for this question. Many candidates produced accurate spellings in each of their responses. Minor spelling errors were tolerated as long as the word would be recognised by a native speaker of Spanish. In many cases, minor spelling errors did not prevent the award of marks (e.g. the words avril and marso were accepted in response to task 5). However, spelling errors which produced a word with a different meaning (e.g. majo instead of mayo) could not be rewarded. Words or phrases that were unrecognisable as Spanish could not be credited (e.g. jacketa). A single word was sufficient to gain the mark for each of the five tasks. Some candidates wrote a short phrase to describe the contents of their suitcase (e.g. pantalones de verano). Such answered were rewarded. Some candidates did not gain the mark for task 1 (tamaño de la maleta) because they did not understand the word tamaño; there were many answers here that could not be credited, such as a weight (e.g. 100 gramos), a simple number (e.g. 12) or a brand (e.g. Samsonite).

## Question 2: La ropa

Most candidates were able to use familiar language and structures when responding to Question 2, and many gained full marks here. Candidates who worked methodically through the tasks in order were less likely to omit one of them. There were many interesting and competent responses which included a variety of less common vocabulary and detailed information, sometimes expressed in more complex language. Weaker candidates struggled to respect gender agreements when using articles, nouns and adjectives.

In the best answers, candidates produced accurate verbs throughout their response. Weaker candidates relied upon infinitives or offered inappropriate tenses and spelling of verbs. There was a wide variation in control of verb formations. Where a spelling error in a verb created a word that did not exist in the verb's paradigm, this was taken into account when establishing the final mark for the piece of writing. The absence of accents on verbs was widespread, but did not usually prevent candidates from achieving a high mark.

Whilst most tasks could be answered using the present tense, other tenses were used appropriately by some candidates. The inappropriate use of several tenses within a response to a single task was often seen. Stronger candidates used a range of basic connectors ( $y$, o, pero, también), whereas weaker candidates tended to rely on $y$ and porque.

Task 1 was answered well by most candidates, who were able to describe the type of clothes that they normally wore by using an adjective (e.g. ancha, cómoda) or by mentioning a brand or a specific type of clothing (e.g. pantalones cortos).

Task 2 required candidates to state why they did or didn't like buying clothes online. There was generally a good response to this task. Some candidates talked about the advantages or/and disadvantages of shopping in shops, without explicitly mentioning online shopping. In such cases, the task could not be considered complete. In response to tasks 1 and 2, it was common to see misspellings of the verbs preferir and gustar. In some cases, the misspellings were still accurate enough for the tasks to be considered complete. There were frequent errors with pronouns (mi or mí was often used where me would have been appropriate) and the plural ending was often seen in place of the singular and vice versa. It was common to see gustar followed by a conjugated verb rather than an infinitive. In addition, candidates need to remember that the verbs preferir and odiar are not reflexive verbs.

Task 3 required candidates to indicate the amount of money that they spent on clothes each month. Although explicit reference to cada mes was not required, candidates needed to indicate a quantity to convey how much they spent. Most usually, candidates who did not provide a satisfactory response to this had either misunderstood the verb gastar or used an inappropriate verb in their answer (e.g. compro 50 euros cada mes, cada mes paso 20 euros).

Tasks 4 and 5 were addressed successfully by most candidates, who were generally able to respond using a future timeframe for either task 4 or for both tasks. A clear reference to the future was needed, either by using a verb referring to the future (e.g. voy a llevar, espero llevar, quiero llevar) or by using the present tense along with a future time phrase (e.g. el próximo fin de semana llevo...). A future reference was not required in both tasks. For example, a statement such as voy a llevar una falda porque hace calor was considered to address both tasks 4 and 5 adequately.

## Question 3: General comments

Most candidates chose Question 3(a), and many produced very engaging responses. The strongest answers were well-structured and showed signs of thoughtful planning. Some candidates gained fewer marks than they could have done because they omitted to cover one or more of the tasks. Candidates generally respected the guidelines about length, producing between 130 and 140 words.

## Task completion

In order to obtain high marks for Task completion, candidates need to ensure that they:

- address all of the tasks given in the question
- provide sufficient information relating to each task by expressing a range of details/opinions/ reactions/explanations - one good strategy that candidates can use is to provide at least two full sentences in response to each task
- address the specific tasks set
- use verbs accurately
- use an appropriate tense and person of the verb when responding to each task
- copy accurately when using words provided in the question.


## Range

Many candidates expressed their ideas using extended, well-linked sentences which demonstrated strong cohesion as well as correct and varied use of vocabulary, verbs and other structures.

The strongest responses included use of subordinate clauses throughout the pieces of writing, introduced by a variety of conjunctions and relative pronouns, appropriate and accurate use of a range of timeframes, and accurately formed verbs in the first, third and, sometimes, second person (including accents, where required). Such responses also tended to include a wide range of interesting vocabulary which was relevant to the question chosen, idiomatic expressions and appropriate use of the subjunctive.

It is important for all candidates to show control of basic structures, including correct spelling and gender. Access to the higher mark bands is more likely to be achieved through accurate and appropriate use of:

- subordinate clauses introduced by conjunctions, relative pronouns, etc., produced throughout the response (e.g. cuando/donde/mientras (que)/visto que/puesto que/dado que/ya que/que/quien/si)
- appropriate formation of constructions with verbs requiring a preposition (e.g. hablar con, con quien hablé)
- a range of timeframes and first-person and third-person verb forms
- adjectives, possessive adjectives, demonstrative adjectives, comparative/superlative adjectives
- adjectival agreement between the subject and its adjective(s)
- correct use and placement of object pronouns in relation to conjugated verbs and infinitives
- negatives, including appropriate word order (e.g. nada/nunca)

Candidates who did not attempt structures from the list above or who did not use subordinate clauses could not go usually achieve a mark higher than five for Range. A response which is entirely, or almost entirely, in short sentences, without any subordinate clauses, is highly likely to be limited to three or four marks for Range. To achieve a mark beyond the 5-6 band, candidates need to ensure that they include a range of tenses, several subordinate clauses, a range of more ambitious connectives (e.g. aunque, además, etc.), opinion markers (e.g. pienso que, opino que, etc.) and vocabulary, as well as some of the structures listed above. In addition, basic structures must, in general, be used successfully.

Some candidates struggled when using both basic and more complex tenses. In order to improve, they need to ensure that they:

- include accents on verbs (where necessary) in the preterite, imperfect, future and conditional tenses
- include the personal a with verbs that require it
- form regular and common irregular verbs in the preterite, particularly the first-person singular (e.g. compré/comí/bebí/vi/elegí/hice/tuve/dije/practiqué/jugué)
- use appropriate prepositions in verb constructions when required (e.g. tengo que, ayudo a, tratar de)
- avoid using tiene where hay is required and vice versa, and es/son where hay is required and vice versa.


## Accuracy

A high level of accuracy is expected for the award of marks in the top band. However, the response does not necessarily have to be faultless in order for such a mark to be given. Responses that contain minor errors (especially in more complex language) which do not affect communication can be considered for the award of marks in the top band.

Frequent inaccuracies will limit the overall mark awarded for Accuracy. Responses which show errors in basic tenses, in adjective-noun agreements and in other basic structures/words are likely to be placed in the $3-4$ band, depending on how often these errors hinder communication. Similarly, candidates who produce a very short text using only basic language cannot usually achieve a mark beyond the 3-4 band, since they will only have demonstrated some accurate spelling and grammar. ## Common errors

The following common errors were seen:

- omission of the relative pronoun que
- inaccurate spelling of simple adjectives and lack of agreement between the subject and the adjective
- inappropriate use of estar when ser was required and vice versa
- incorrect combinations of ser/estar with bueno/bien and malo/mal
- use of third-person singular of ser with a plural subject and third-person plural of ser with a singular subject
- incorrect formation of gustar/encantar in the present and conditional tenses, including the omission of the preceding a (e.g. a mí, me gusta).
- incorrect spelling of preferir in the present
- incorrect formation of hacer/tener/poner/poder/querer in the preterite tense
- use of fue/fuiste when fui was intended
- use of third-person formation when the first-person was intended
- omission of the appropriate preposition in verb constructions (e.g. ayudar a, ir a, tratar de)
- inappropriate inclusion of a preposition in verb constructions (e.g. es importante de, necesito de)
- omission of the preposition following verbs (e.g. fui a la casa de mi amigo, he soñado con)
- inappropriate translation of idioms from the candidate's first language (e.g. 'to have a good time' was translated literally as tener un buen tiempo when the Spanish idiom pasarlo bien was intended).

## Question 3(a): Un viaje al extranjero

This was the more popular option. Most candidates attempted or successfully addressed most of the tasks. There were good attempts at explanations and developments, and a significant number of candidates engaged well with the register of the task (i.e. an email to a friend).

## Task completion

Task 1 required candidates to provide a description of the place that they had visited last summer. Almost all candidates provided an acceptable response in term of content, but if the response included an inappropriate verb form, then the task could not be considered complete. The second-person verb form fuiste was often copied unaltered from the question.

Task 2 was answered successfully by most candidates, who most usually described a problem at the hotel or at the airport, or an issue concerning their family. Some candidates omitted to provide a response to this task. A number of responses contained inappropriate verb forms, particularly the second-person verb form tuviste which had been lifted unaltered from the question. In such cases the task could not be considered complete. In a few cases, it was clear that candidates were attempting to address the task but were unsuccessful either because they did not describe a problem that they had had or because they offered only positive aspects of some element of their trip.

Task 3 required candidates to state their preferred means of transport. Most candidates were able to provide a very simple statement to address the task, and the stronger candidates extended their answer by explaining why. A lack of control of preferir and viajar meant that the task could not be considered complete in a number of cases, but misunderstanding the task was the most common reason for candidates being unsuccessful here. Some candidates wrote about their favourite means of transport during the specific trip that they had been on rather than writing about their preference in general.

Task 4 required candidates to explain the reasons why it is important to travel to other countries. Many candidates gave a very detailed explanation, focusing on the benefits of experiencing a new culture, sampling a new cuisine and meeting new people. They often used this question to introduce more complex ideas and language. Others gave a very brief and straightforward answer.

Task 5 required candidates to describe with whom they would travel in future. Most candidates were confident using a future timeframe. Responses varied from the very brief to very detailed. The more detailed answers often explained the reasons for the choice of travelling companion and/or what the candidate planned to do on the future trip. The second-person verb form vas was sometimes copied unaltered from the question, meaning that the task could not be considered complete. Some candidates described a future trip without mentioning with whom they would go.

## Range

Some candidates demonstrated a strong grasp of the language, combining fluency, breadth and variety. These candidates used a broad range of tenses, which were mostly accurate, combined with other complex grammar and vocabulary. Only those candidates who could produce longer, complex sentences linked with a range of connectors could score a mark in the top band. For some candidates, it often proved difficult to gain a mark higher than five or six due to a lack of more complex tenses, grammar and vocabulary. Some of the most common errors were inaccuracy of tenses (especially the preterite tense), an insufficient range of tenses and other complex structures, and ideas presented as a list of simple sentences with no attempt at linkage.

## Accuracy

The stronger candidates, who often scored marks in the top mark band, tended to produce pieces of writing that contained only very minor errors that did not impede communication. The most common errors which hindered communication were errors with the subject, tenses or verbs.

## Question 3(b): Una fiesta de fin de curso

This was the less popular option. Most of those who chose it were weaker candidates and performance here was generally not as good as on Question 3(a). Many candidates made an attempt to address most of the tasks. There were some good attempts at explanations and development of ideas, and some candidates engaged well with the register of the task, i.e. an article for the school magazine.

## Task completion

A significant number of responses contained the second-person verb form organizaste, which had been lifted directly from the question, and in such cases task 1 could not be considered complete. Responses tended to be short, although there were some more detailed attempts. Some candidates described the school and its facilities but made no reference to a venue for the fiesta. Some candidates named a different person as the party organiser, which might have been due to either a misunderstanding of the word organizaste, or to not reading the rubric carefully enough. These answers could not be considered relevant to the task.

Task 2 asked candidates to state what they did at the party. The stronger candidates mentioned several things, using a range of verbs in the preterite tense and giving detailed explanations. Weaker candidates struggled to use an accurate verb in the preterite or used the present tense instead. The task could therefore not be considered complete. Some candidates merely wrote about what there was at the party without describing what they did there.

Task 3 required candidates to state the type of music that they like listening to at parties. Responses to this task tended to be brief, but almost all candidates managed to address it successfully. The stronger candidates often included a justification for their choice. Weaker candidates showed a lack of control of the verb formations of gustar and preferir, which prevented this task from being considered complete. Inappropriate past tenses and generalised answers (with no mention of music at a fiesta) also resulted in this task being considered incomplete. Some candidates wrote about the music at the end-of-term party with no mention of their own preference; such answers were considered to be irrelevant.

Task 4 was attempted by most candidates. Some responses were very brief; others were very detailed and included accurate language and complex structures. The stronger candidates often used the construction es importante que los jóvenes followed by a conjugated subjunctive verb. Many candidates relied upon the wording of the question to introduce their response. It was not uncommon to see several explanations, only one of which had an acceptable verb form.

Task 5 required candidates to say what event they would attend next. Some candidates answered with a short, simple sentence in which an accurate form of the immediate future was produced. Other candidates who adopted the same approach did not address the task successfully because they lifted the secondperson verb form vas unaltered from the question. A small number of candidates included neither the future time phrase used in the question nor a verb in the future/immediate future/conditional; in such cases the task was considered incomplete because the response was usually a generalisation rather than a specific statement. There were successful responses which included detailed explanations and contained accurate future verb forms, including me gustaría followed by an infinitive. The stronger candidates used clauses introduced by si or other complex constructions such as espero que or ojalá followed by the subjunctive.

## Range

Some candidates were able to include a wide range of connectives and appropriate linking words. The stronger candidates included an extremely wide range in their responses, such as si, cuando, para que, aunque, debido a, lo que, etc. Most candidates tended to use simple structures and made attempts to use more complex structures. The stronger candidates used a wide range of complex structures, including, sometimes, a wide range of connectives within one sentence. Some candidates were able to include accurate examples of the most complex structures, including subjunctive structures, indirect pronouns, the pluperfect tense, etc. These candidates also often used a wide range of vocabulary specific to the topic. Some of the most common errors were inaccuracy of tenses (especially the preterite tense), an insufficient range of tenses and other complex structures, and ideas presented as a list of simple sentences with no attempt at linkage.

Accuracy
Most candidates tended to use simple structures accurately. The most common errors which hindered communication were errors with the subject, tenses or verbs.

# SPANISH (Foreign Language) 

## Paper 0530/43 <br> Writing

## Key messages

- Candidates should read the initial rubric of each question and each task carefully to ensure that the response that they produce is relevant and includes appropriate tenses.
- In order to ensure that they respond to all the tasks in Questions 2 and 3, candidates may benefit from attempting the tasks in the order in which they appear on the question paper.
- Candidates should recognise the need to use an appropriate range of structures, tenses and vocabulary in their response to Question 3 in order to give themselves access to the full range of marks available. Similarly, they need to develop their answers by including additional information (e.g. explanations, reasons, opinions, etc.).
- Candidates should pay careful attention to the formation of vowels and the placement of accents as these features can affect the marks for the three criteria in Question 3.
- It is recommended that candidates adhere to the word counts for Question 2 and Question 3.


## General comments

Work from the whole ability range was seen. Many candidates performed very well in Questions 1 and 2. In Question 3 stronger candidates showed control of varied sentence structures and verb tenses, and complex linguistic structures were seen, including idiomatic expressions.

In Question 1 candidates should always try to produce an answer for each of the five gaps. They need to read the initial rubric carefully, as well as the tasks themselves, so that they can provide appropriate responses. Candidates should avoid writing answers outside the dotted lines provided. Extra answers for one task cannot compensate for other tasks that have not been attempted or that are incorrect.

In Question 2, up to 12 marks are awarded based on task completion, relevance, clarity of the message, variety of vocabulary and structures, and the use of linking words. There is no requirement to provide the same amount of information for each of the tasks. Candidates should be reminded that the maximum of 12 marks cannot be awarded if they omit or do not successfully convey at least one detail for each of the tasks, including tasks that include two elements. Candidates are required to write responses in full sentences and to form their response as a piece of prose, rather than as a series of bullet points. Candidates need to produce a recognisable part of an appropriate verb in order to gain credit for task completion. It is acceptable for two tasks to be completed in a single sentence. Candidates need to link their words, phrases and sentences using a range of simple connectors (e.g. y, también, pero, etc.).

Question 3 offers a choice of two options: a letter/email and a report/article. There are 10 marks available for Task Completion, 10 marks for Range and 8 marks for Accuracy. The marks for Range are awarded based on the candidates' ability to extend and link sentences, and the range of tenses and other structures used, as well as the range of vocabulary. Candidates should ensure that they select the question which will allow them to best show the Spanish that they know. Candidates should read through both options before choosing which one to answer. A close reading of the tasks within the questions is recommended as this will allow candidates to think about the vocabulary and structures that they will need to use in order to respond effectively and fully to the question.

Task completion: For a task to be consider complete, candidates must respond to the task using the tense required by the task with the production of a wholly accurate verb. Minor spelling errors might be tolerated, e.g. when a missing accent does not produce another tense which causes ambiguity.

Range: The use of extended sentences, a range of connectives, tenses, varied structures including idioms and vocabulary is required in order to reach the top mark band. When the descriptor states 'uses', it should be read as 'uses successfully'. Candidates who struggle to use basic tenses are likely to achieve a maximum of five marks for Range. Only those who attempt some complex structures are able to access a mark of six or higher for Range.

Accuracy: Candidates do not have to produce a perfectly accurate piece of writing in order to achieve the full 8 marks available for Accuracy. Minor errors which do not impede communication will not be penalised.

When finalising their responses for Question 2 or Question 3, candidates need to be careful if they decide to cross out any parts of their response. There were some instances where crossing-out had occurred, and this affected the coherence and clarity of the piece of writing overall.

## Comments on specific questions

## Question 1: Quieres ayudar en un campamento de música para niños pequeños.

The majority of candidates achieved the full five marks available for this question. Many candidates produced accurate spellings in each of their responses. Minor spelling errors were tolerated as long as the word would be recognised by a native speaker of Spanish. In many cases, minor spelling errors did not prevent the award of marks (e.g. the words avril and marso were accepted in response to task 5). However, spelling errors which produced a word with a different meaning (e.g. majo instead of mayo) could not be rewarded. Words or phrases that were unrecognisable as Spanish could not be credited (e.g. ir de shopping). A single word was sufficient to gain the mark for each of the five tasks. Some candidates wrote a short phrase, in which they included a verb, to indicate their hobbies. The noun describing the hobby on its own was sufficient to get the mark, but answers containing a verb (such as jugar al baloncesto) were also rewarded. Some candidates did not gain the mark for task 1 (idiomas que hablas) because they mentioned a school subject (e.g. matemáticas) instead of a language. Handwriting was sometimes an issue, especially with the vowels $o$ and $a$.

## Question 2: Mi dormitorio

Most candidates were able to use familiar language and structures when responding to Question 2, and many gained full marks here. Candidates who worked methodically through the tasks in order were less likely to omit one of them. There were many interesting and competent responses which included a variety of less common vocabulary and detailed information, sometimes expressed in more complex language. Weaker candidates struggled to respect gender agreements when using articles, nouns and adjectives.

In the best answers, candidates produced accurate verbs throughout their response. Weaker candidates relied upon infinitives or offered inappropriate tenses and spelling of verbs. There was a wide variation in control of verb formations. Where a spelling error in a verb created a word that did not exist in the verb's paradigm, this was taken into account when establishing the final mark for the piece of writing. The absence of accents on verbs was widespread, but did not usually prevent candidates from achieving a high mark.

Whilst most tasks could be answered using the present tense, other tenses were used appropriately by some candidates. The inappropriate use of several tenses within a response to a single task was often seen. Stronger candidates used a range of basic connectors ( $y$, o, pero, también), whereas weaker candidates tended to rely on $y$ and porque.

Task 1 was answered well by most candidates, who were able to describe their bedroom by using an adjective (e.g. es grande) or by mentioning what they had in their bedroom (e.g. tiene una televisión).

Task 2 required candidates to state what they liked most about their bedroom. The candidates who clearly stated a preference by lifting the expression from the question (lo que más me gusta) or by using a verb of preference (e.g. prefiero, me encanta, me gusta mucho) usually completed the task successfully. Some candidates listed several positive things about their bedroom without indicating what they liked the most. In response to tasks 1 and 2, it was common to see misspellings of the verbs preferir and gustar. In some cases, the misspellings were still accurate enough for the tasks to be considered complete. There were frequent errors with pronouns ( $m i$ or mí was often used where me would have been appropriate) and the plural ending was often seen in place of the singular and vice versa. It was common to see gustar followed by a conjugated verb rather than an infinitive. In addition, candidates need to remember that the verbs preferir and odiar are not reflexive verbs.

Tasks 3 and 4 required candidates to indicate the amount of time that they spent in their room and why. Answers which referred to a general amount of time (e.g. paso mucho tiempo en mi dormitorio) were considered to have addressed task 3. Some candidates gave a detailed explanation of what they usually did in their bedroom without a specific reference to the time that they spent there. Similarly, some candidates who did not manage to complete this task had misunderstood the verb pasar, or used an incorrect verb in their answer (e.g. gasto cinco horas or uso cinco horas). In such cases, task 3 was not considered to have been addressed successfully. Some candidates did not give a reason and in such cases task 4 couldn't be considered complete. However, most candidates were able to give a reason, and the most frequent one was related to covid-19 restrictions.

Task 5 was addressed successfully by most candidates, who were able to respond using a future timeframe. A clear reference to the future was needed, either by using a verb referring to the future (e.g. me gustaría cambiar, voy a cambiar, espero cambiar, quiero cambiar) or by using the present tense along with a future time phrase (e.g. en el futuro cambio...).

## Question 3: General comments

Most candidates chose Question 3(a), and many produced very engaging responses. The strongest answers were well-structured and showed signs of thoughtful planning. Some candidates gained fewer marks than they could have done because they omitted to cover one or more of the tasks. Candidates generally respected the guidelines about length, producing between 130 and 140 words.

## Task completion

In order to obtain high marks for Task completion, candidates need to ensure that they:

- address all of the tasks given in the question
- provide sufficient information relating to each task by expressing a range of details/opinions/ reactions/explanations - one good strategy that candidates can use is to provide at least two full sentences in response to each task
- address the specific tasks set
- use verbs accurately
- use an appropriate tense and person of the verb when responding to each task
- copy accurately when using words provided in the question.


## Range

Many candidates expressed their ideas using extended, well-linked sentences which demonstrated strong cohesion as well as correct and varied use of vocabulary, verbs and other structures.

The strongest responses included use of subordinate clauses throughout the pieces of writing, introduced by a variety of conjunctions and relative pronouns, appropriate and accurate use of a range of timeframes, and accurately formed verbs in the first, third and, sometimes, second person (including accents, where required). Such responses also tended to include a wide range of interesting vocabulary which was relevant to the question chosen, idiomatic expressions and appropriate use of the subjunctive.

It is important for all candidates to show control of basic structures, including correct spelling and gender.
Access to the higher mark bands is more likely to be achieved through accurate and appropriate use of:

- subordinate clauses introduced by conjunctions, relative pronouns, etc., produced throughout the response (e.g. cuando/donde/mientras (que)/visto que/puesto que/dado que/ya que/que/quien/si)
- appropriate formation of constructions with verbs requiring a preposition (e.g. hablar con, con quien hablé)
- a range of timeframes and first-person and third-person verb forms
- adjectives, possessive adjectives, demonstrative adjectives, comparative/superlative adjectives
- adjectival agreement between the subject and its adjective(s)
- correct use and placement of object pronouns in relation to conjugated verbs and infinitives
- negatives, including appropriate word order (e.g. nada/nunca)
- correct use of por and para
- adverbs, prepositional phrases, time references, opinion markers
- linking words other than $y$, pero and porque
- definite and indefinite articles.

Candidates who did not attempt structures from the list above or who did not use subordinate clauses could not go usually achieve a mark higher than five for Range. A response which is entirely, or almost entirely, in short sentences, without any subordinate clauses, is highly likely to be limited to three or four marks for Range. To achieve a mark beyond the 5-6 band, candidates need to ensure that they include a range of tenses, several subordinate clauses, a range of more ambitious connectives (e.g. aunque, además, etc.), opinion markers (e.g. pienso que, opino que, etc.) and vocabulary, as well as some of the structures listed above. In addition, basic structures must, in general, be used successfully.

Some candidates struggled when using both basic and more complex tenses. In order to improve, they need to ensure that they:

- include accents on verbs (where necessary) in the preterite, imperfect, future and conditional tenses
- include the personal a with verbs that require it
- form regular and common irregular verbs in the preterite, particularly the first-person singular (e.g. compré/comí/bebi/vi/elegí/hice/tuve/dije/practiqué/jugué)
- use appropriate prepositions in verb constructions when required (e.g. tengo que, ayudo a, tratar de)
- avoid using tiene where hay is required and vice versa, and es/son where hay is required and vice versa.


## Accuracy

A high level of accuracy is expected for the award of marks in the top band. However, the response does not necessarily have to be faultless in order for such a mark to be given. Responses that contain minor errors (especially in more complex language) which do not affect communication can be considered for the award of marks in the top band.

Frequent inaccuracies will limit the overall mark awarded for Accuracy. Responses which show errors in basic tenses, in adjective-noun agreements and in other basic structures/words are likely to be placed in the $3-4$ band, depending on how often these errors hinder communication. Similarly, candidates who produce a very short text using only basic language cannot usually achieve a mark beyond the 3-4 band, since they will only have demonstrated some accurate spelling and grammar. Candidates who persistently struggle with accuracy in very basic language and whose errors persistently impede communication are likely to be placed in the 1-2 band.

## Common errors

The following common errors were seen:

- omission of the relative pronoun que
- inaccurate spelling of simple adjectives and lack of agreement between the subject and the adjective
- inappropriate use of estar when ser was required and vice versa
- incorrect combinations of ser/estar with bueno/bien and malo/mal
- use of third-person singular of ser with a plural subject and third-person plural of ser with a singular subject
- incorrect formation of gustar/encantar in the present and conditional tenses, including the omission of the preceding a (e.g. a mí, me gusta).
- incorrect spelling of preferir in the present
- incorrect formation of hacer/tener/poner/poder/querer in the preterite tense
- use of fue/fuiste when fui was intended
- use of third-person formation when the first-person was intended
- omission of the appropriate preposition in verb constructions (e.g. ayudar a, ir a, tratar de)
- inappropriate inclusion of a preposition in verb constructions (e.g. es importante de, necesito de)
- omission of the preposition following verbs (e.g. fui a la casa de mi amigo, he soñado con)
- inappropriate translation of idioms from the candidate's first language (e.g. 'to have a good time' was translated literally as tener un buen tiempo when the Spanish idiom pasarlo bien was intended).

## Question 3(a): Un nuevo restaurante

This was the more popular option. Most candidates attempted or successfully addressed most of the tasks. A wide range of restaurants and dishes were described, and many candidates explained why they believed it was important to try food from different countries. There were good attempts at explanations and developments, and a significant number of candidates engaged well with the register of the task (i.e. an email to a friend).

## Task completion

Candidates were able to address task 1 by using the verb comer, tomar or elegir in the preterite tense. Most answers included a detailed description of the restaurant and the dishes ordered. However, some candidates omitted the key point: what they chose to eat. The verb elegir was problematic for weaker candidates. Some weaker candidates, who were unsure how to manipulate elegiste, thought carefully about the Spanish that they did know, and instead used the verb comí or bebí in order to address the task successfully.

Task 2 was answered successfully by most candidates. The responses varied from very straightforward and brief answers with the verb era and an adjective to much more detailed answers where candidates explained what the waiter or waitress did. Some candidates wrote a description using the present tense and in such cases the task couldn't be considered complete.

Task 3 was also addressed successfully by many candidates, with most writing in detail about the restaurants that they normally go and including such details as why, with whom, etc. A small number of candidates omitted to write a response to this task.

Most candidates attempted task 4. There was a broad range of reasons given for why it is beneficial to eat food from different countries. Almost all candidates had a positive view of food from other countries. Some of the ideas given included puedes aprender sobre culturas diferentes, es útil para conocer el mundo and ayuda para trabajar en otros países, etc. A common mistake was the misuse of the word culturales instead of culturas.

Task 5 required candidates to invite a friend to eat with them next weekend. Candidates who wrote a simple phrase such as ¿Te gustaría ir a un restaurante? or Podemos ir a un restaurante addressed the task successfully. However, a significant number of candidates got themselves in a muddle by attempting a very complex invitation, and did not manage to produce a response that was adequate to address the task.

## Range

In general, simple structures were used correctly, and there was some evidence of linkage in most answers. The best answers were clearly structured and used different paragraphs for each task. The best answers showed excellent use of complex structures. For some candidates, it often proved difficult to gain a mark higher than five or six due to an insecure grasp of a range of tenses. In weaker responses, there was a frequent lack more complex structures. The connective porque was the main connective used and, in some cases, the only one.

## Accuracy

The stronger candidates tended to produce accurate verbs throughout their responses. Accurate use of at least three tenses was common, with the best answers showing excellent control of different tenses. Weaker candidates struggled with accurate verb formation.

## Question 3(b): Un intercambio

This was the less popular option, but those who did choose it often produced very imaginative answers.

## Task completion

Task 1 was a very straightforward task and most candidates answered it successfully. The best answers included a detailed description with some personal opinions. The most successful answers included comparisons with their current school. Answers using a verb in the present tense or a past tense were accepted. Stronger candidates used que to extend their description and other subordinate clauses.

Task 2 was misread by some candidates, who described what they did with their friends but did not specify what they did in order to make new friends. The stronger candidates wrote about the different activities that they did, using a range of verbs in the preterite and the pluperfect tense.

Task 3 required candidates to write about the weather in the past. A significant number of candidates could not use a correct verb form in the past. Some candidates wrote phrases such as era sol or estaba lluvia, or used the present tense. The stronger candidates accurately used expressions with hizo/hacía, or wrote a phrase like el tiempo era perfecto/ideal para... followed by infinitive. Some candidates used this task as an opportunity to mention problems with clothes which then become one of the recommendations that they made in response to task 5 . This was a good example of planning and linking tasks in order to produce a strong piece of writing.

Task 4 was generally tackled very well. A broad range of personal reasons were given, and most candidates extended their answers with detailed explanations and opinions.

Task 5 required candidates to produce a recommendation. A simple statement with deberían plus an infinitive was sufficient to address the task. However, many candidates tried to produce unnecessarily complex answers with recomendaría a los estudiantes que..., but could not produce a sufficiently accurate sentence. Many candidates misunderstood the question and wrote about the importance of taking part in a school exchange.

## Range

This question differentiated very well, allowing the stronger candidates to use a wide range of complex structures and vocabulary related to the topic. The responses of weaker candidates tended to lack a range of vocabulary and verbs, with their responses to tasks 1 and 2 mainly relying on era, tenía and había. The use of future tenses was sometimes omitted.

## Accuracy

Again, this question differentiated well in terms of the mark for Accuracy. The responses of weaker candidates showed many mistakes in the formation of verbs, especially the past tenses. Some candidates included incongruous complex structures or idiomatic expressions in their answers, perhaps in the hope of attracting additional credit. Candidates need to remember that the use of such structures or expressions need to make sense in the context of the response, so when they are used incorrectly or inappropriately, they can affect the mark awarded for Accuracy.
