- 1 The series S is given by $S = \sum_{r=0}^{N} (N+r)^2$.
 - (i) Write out the first three terms and the last three terms of the series for S. [1]
 - (ii) Use the standard result $\sum_{r=1}^{n} r^2 = \frac{1}{6}n(n+1)(2n+1)$ to show that $S = \frac{1}{6}N(N+1)(aN+1)$ for some positive integer a to be determined. [4]
- 2 (i) Show that there is a value of t for which **AB** is an integer multiple of the 3×3 identity matrix **I**, where

$$\mathbf{A} = \begin{pmatrix} 1 & 2 & 1 \\ t & 1 & -t \\ 3 & 2 & 1 \end{pmatrix} \quad \text{and} \quad \mathbf{B} = \begin{pmatrix} t - 2 & 0 & 5 \\ 12 & -2 & -6 \\ 3t & 4 & 7 \end{pmatrix}.$$

(ii) Express the system of equations

$$-5x + 5z = 8$$

 $12x - 2y - 6z = 12$
 $-9x + 4y + 7z = 22$

in the form Cx = u, where C is a 3 × 3 matrix, and x and u are suitable column vectors. [1]

- (iii) Use the result of part (i) to solve the system of equations given in part (ii). [3]
- 3 (i) On a single copy of an Argand diagram, sketch the loci defined by

$$|z+2| = 3$$
 and $\arg(z-i) = -\frac{1}{4}\pi$. [4]

- (ii) State the complex number z which corresponds to the point of intersection of these two loci. [1]
- 4 Let $I_n = \int_0^4 x^n \sqrt{2x+1} \, dx$ for $n \ge 0$. Show that, for $n \ge 1$,

$$(2n+3)I_n = 27 \times 4^n - nI_{n-1}.$$

- 5 The curve C has equation $y = \frac{12(x+1)}{(x-2)^2}$.
 - (i) Determine the coordinates of any stationary points of C. [4]

(ii) Sketch
$$C$$

Solve the first-order differential equation $x \frac{dy}{dx} + 2y = 4 \ln x$ given that y = 1 when x = 1. Give your answer in the form y = f(x).

- 7 Let $f(n) = 11^{2n-1} + 7 \times 4^n$. Prove by induction that f(n) is divisible by 13 for all positive integers n.
- 8 (i) Show that the line l with vector equation $\mathbf{r} = \begin{pmatrix} 2 \\ -5 \\ 7 \end{pmatrix} + \lambda \begin{pmatrix} 5 \\ -2 \\ 3 \end{pmatrix}$ lies in the plane Π with cartesian equation x + 4y + z + 11 = 0.
 - (ii) The plane Π is horizontal, and the point P(1, 2, k) is above it. Given that the point in Π which is directly beneath P is on the line l, determine the value of k.
- 9 (i) Explain why all groups of even order must contain at least one self-inverse element (that is, an element of order 2).
 - (ii) Prove that any group in which every non-identity element is self-inverse is abelian. [2]
 - (iii) Simon believes that if x and y are two distinct self-inverse elements of a group, then the element xy is also self-inverse. By considering the group of the six permutations of (1 2 3), produce a counter-example to prove him wrong.
 - (iv) A group G has order 4n + 2, for some positive integer n, and i is the identity element of G. Let x and y be two distinct self-inverse elements of G. By considering the set $H = \{i, x, y, xy\}$, prove by contradiction that G cannot contain all self-inverse elements. [5]
- 10 (i) Use de Moivre's theorem to show that $2\cos 6\theta = 64\cos^6 \theta 96\cos^4 \theta + 36\cos^2 \theta 2$. [5]
 - (ii) Hence find, in exact trigonometric form, the six roots of the equation

$$x^6 - 6x^4 + 9x^2 - 3 = 0.$$

(iii) By considering the product of these six roots, determine the exact value of

$$\cos\left(\frac{1}{18}\pi\right)\cos\left(\frac{5}{18}\pi\right)\cos\left(\frac{7}{18}\pi\right).$$

- 11 A curve has polar equation $r = e^{\sin \theta}$ for $-\pi < \theta \le \pi$.
 - (i) State the polar coordinates of the point where the curve crosses the initial line. [1]
 - (ii) State also the polar coordinates of the points where r takes its least and greatest values. [2]
 - (iii) Sketch the curve. [3]
 - (iv) By deriving a suitable Maclaurin series up to and including the term in θ^2 , find an approximation, to 3 decimal places, for the area of the region enclosed by the curve, the initial line and the line $\theta = 0.3$.

12 (i) (a) Show that
$$\tanh x = \frac{e^{2x} - 1}{e^{2x} + 1}$$
. [2]

- **(b)** Hence, or otherwise, show that, if $\tanh x = \frac{1}{k}$ for k > 1, then $x = \frac{1}{2} \ln \left(\frac{k+1}{k-1} \right)$ and find an expression in terms of k for $\sinh 2x$.
- (ii) A curve has equation $y = \frac{1}{2} \ln(\tanh x)$ for $\alpha \le x \le \beta$, where $\tanh \alpha = \frac{1}{3}$ and $\tanh \beta = \frac{1}{2}$. Find, in its simplest exact form, the arc length of this curve. [10]
- 13 The complex number w has modulus 1. It is given that

$$w^2 - \frac{2}{w} + k\mathbf{i} = 0,$$

where k is a positive real constant.

(i) Show that
$$k = (3 - \sqrt{3})\sqrt{\frac{1}{2}\sqrt{3}}$$

(ii) Prove that at least one of the remaining two roots of the equation $z^2 - \frac{2}{z} + ki = 0$ has modulus greater than 1.
