## Unit F523 Design Make and Evaluate

### Section 4a Mark Grid

#### **DESIGN, DESIGN DEVELOPMENT and MAKING**

Demonstrate competence in the design, design development and making of the product, to include the following package of evidence:

- 1 the generation and exploration of design possibilities;
- 2 the use of digital technologies;
- 3 experimenting and modelling;
- 4 the refining and defining of a final design through ongoing evaluation;
- 5 the planning and making of the product.

#### **Explanatory notes**


The Assessment Criteria for Section 4a are detailed in Appendix E of the Specification. The first bulleted descriptor in each mark band is an 'overall' descriptor for the work in that band. The remaining five bullet points in each mark band refer to each of the five strands in turn.

The Assessment Criteria for this section allow for the flexibility of approach which is a feature of this Unit. Candidates are not limited or constrained to a prescribed approach in their designing and making. The package of evidence of the candidates work should include evidence against all five stands listed. However, the five strands do not have an equal or fixed weighting and the balance and emphasis of skills will vary considerably, particularly between material focus areas.

Award a mark for each strand by shading the appropriate square in the grid. In the 'EXAMPLE CANDIDATE' column, marks for strands 1 to 5 were awarded marks of 37, 44, 45, 28, and 31 respectively.

Consider the relevance and relative importance of each of the strands in the designing and making of the particular product. Consider the 'overall package of evidence' presented against all five strands.

Use the descriptors in each mark band to determine an overall 'best-fit' mark that reflects the particular demands of the project and the overall level of capability and skill shown by the candidate. In the 'EXAMPLE CANDIDATE' column, a best fit mark of 38 was awarded.
