- AO3: relevant research and analysis on the value of the complementary therapy used by the person who uses services to determine the views of members of the public and healthcare practitioners [10];
- AO4: an evaluation of how well the person who uses services has had their needs met by the complementary therapy and orthodox medicine [10].
